## THE COMMISSION WILL CONSIDER AND MAY TAKE ACTION ON THE FOLLOWING ITEMS:

- 1. CONSENT CALENDAR. (Items on the Consent Calendar will be taken up and voted on as a group. A commissioner may request that an item be moved and discussed later in the meeting.)
  - a. NATIONAL ASSOCIATION OF STATE ENERGY OFFICIALS. Proposed resolution approving Agreement 150-18-002 with the National Association of State Energy Officials (NASEO) for a \$9,999 sponsorship contract to support the research and development of the 2019 U.S. Energy & Employment Report. (ERPA funding) Contact: Michael Poe.
  - b. NATIONAL ASSOCIATION OF STATE ENERGY OFFICIALS. Proposed resolution approving Agreement 200-18-001 with the National Association of State Energy Officials (NASEO) for a \$23,608 contract to formalize the Energy Commission's membership. This one-year membership allows Energy Commission staff to connect with key policy and decision makers; officials from other state and territorial energy offices; and affiliates from the private and public sectors. The membership also provides a forum for exchanging information, ideas and resources, and to learn about new funding and partnership opportunities. (ERPA funding) Contact: Andrea Hoppe.
  - c. THE SOLAR FOUNDATION. Proposed resolution approving Agreement 150-18-003 with The Solar Foundation for a \$5,000 sponsorship contract to support the research and implementation of the 2018 Solar Jobs Census, including California-specific data. (ERPA funding) Contact: Michael Poe.
  - d. FOOD PRODUCTION INVESTMENT PROGRAM. Proposed resolution approving an amendment to the Food Production Investment Program Guidelines to clarify the technical scoring criteria for priority populations and California-based vendors. (GGRF funding) Contact: Virginia Lew.
- 2. DEPARTMENT OF GENERAL SERVICES. Informational presentation by the Department of General Services (DGS) to discuss how DGS has expanded the use of renewable energy by the State of California. Contact: Drew Bohan. (Staff presentation: 10 minutes)
- 3. LEED GOLD AWARDED TO WARREN-ALQUIST STATE ENERGY BUILDING. Staff presentation describing the team effort to achieve a building designation of LEED

Gold for the California Energy Commission building. The LEED certification initiative is based on the 2012 Governor Brown Executive Order B-18-12, which directed state agencies to take steps to reduce greenhouse gas emissions for the state of California. - 4. AMENDMENTS TO THE TITLE 20 APPLIANCE EFFICIENCY REGULATIONS RULEMAKING (18-AAER-10). Proposed resolution adopting amendments to the Title 20 Appliance Efficiency Regulations, sections 1601-1609. The proposed amendments reflect the most current federal regulations regarding appliance efficiency and update state-specific regulations. The proposed amendments also make changes to reflect the use of the new Modernized Appliance Efficiency Database System (MAEDbS) and changes to the certification process. The rulemaking does not change the underlying energy or water efficiency standards for any appliance or result in any changes in the estimated energy or water savings from the standards set by the Title 20 appliance efficiency regulations. - 5. ALAMEDA COUNTY. Proposed resolution finding that Alameda County's locally adopted building energy standards will require equal or greater energy efficiency than the 2016 Building Energy Efficiency Standards (2016 Energy Standards). The ordinance requires installation of solar photovoltaics in all new single-family and low-rise multifamily construction according to a prescriptive or performance pathway based on climate zone. - 6. CITY OF CHULA VISTA. Proposed resolution finding that the city of Chula Vista's locally adopted building energy standards will require equal or greater energy efficiency than the 2016 Energy Standards. The ordinance reduces the maximum outdoor lighting power allowances, from the maximum allowed wattages in the 2016 Energy Standards for nonresidential building occupancies, by 32 to 81 percent, depending on the application. - 7. THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, ON BEHALF OF THE LOS ANGELES CAMPUS. Proposed resolution approving Agreement EPC-17-050 with The Regents of the University of California, on behalf of the Los Angeles campus, for a \$1,098,662 grant for detailed urban energy planning that considers urban renewable sources, energy efficiency, building retrofits, electrification, air quality and greenhouse gas emissions, and environmental justice concerns resulting in actionable recommendations for the targeted area. - 8. RIALTO BIOENERGY FACILITY, LLC. Proposed resolution adopting California Environmental Quality Act findings and statement of overriding considerations for Rialto Bioenergy Facility, LLC's microgrid project and approving Agreement EPC-17-054 with Rialto Bioenergy Facility, LLC.   - a. CALIFORNIA ENVIRONMENTAL QUALITY ACT FINDINGS. Findings that based on the Lead Agency, City of Rialto's, certified Final Environmental Impact Report; adopted Mitigation, Monitoring and Reporting Program; adopted Statement of Overriding Considerations; resolution regarding the aforementioned documents; Notice of Determination; and Notice of Exemption for the energy storage component of project, the work under the proposed project presents no new significant or substantially more severe environmental impacts beyond those already considered; and adopting a statement of overriding considerations.

- b. RIALTO BIOENERGY FACILITY, LLC'S MICROGRID PROJECT. Agreement with Rialto Bioenergy Facility, LLC for a \$5,000,000 grant to install a permanent microgrid that manages multiple distributed energy resources to meet power demand loads at the Rialto Bioenergy Facility and providing islanding abilities, while minimizing grid draw and enhancing renewable electricity export.
