Request for Additional Information to Improve the Home Energy Rating System Program

California Energy Commission staff will conduct a Staff Webinar to obtain additional information from stakeholders interested in improving the California Home Energy Rating System (HERS) Program. The Commission opened the HERS Order Instituting Informational (OII) Proceeding, Order No. 12-1114-6, late in 2012, as a means to collect necessary information to identify potential procedures and other actions that would remedy administrative shortcomings in the HERS Program.

Purpose and Agenda

To date, stakeholders have participated in the HERS OII proceedings and provided valuable input to the record. Official notices, transcripts, and comments are available at: <http://www.energy.ca.gov/HERS/12-HERS-01/documents/>

The purpose of this webinar is to discuss the status of the HERS OII and solicit input on the HERS Program in relation to HERS field verification or diagnostic testing. To date the proceeding has identified the following five topics:

- Provider Quality Assurance Programs
- HERS Rater Disciplinary Process
- HERS Rater Companies
- Conflict of Interest
- Permissible HERS Provider Certification Categories

Staff plans to review the five topics to determine if they are still applicable and identify any changes. In addition, staff seeks to identify new topics or issues relating to HERS field verification or diagnostic testing.

Energy Commission staff will provide a brief overview of the expected process and outcome of the continuing OII. Information gathered may result in development of recommendations for Commission consideration in a future rulemaking.

Background

Public Resources Code section 25942 directs the Energy Commission to establish criteria for a statewide home energy rating system program. The Commission's regulations implementing this program are the California Home Energy Rating System (HERS) Regulations, Title 20, Cal. Code Regs, Section 1670 et seq. The Energy Commission approves and regulates HERS Providers who train and certify raters. These certified Raters verify that contractors have properly installed the required energy efficiency measures.

The overall goal of the HERS program is to ensure that when an energy efficiency upgrade is made to a building, that it not only meets the Building Energy Efficiency Standards but also that the systems installed are operating at a level of performance that reflects the value of the Standards to the consumer. The HERS program is a consumer protection service designed to ensure that homeowners receive properly installed energy efficiency measures.

Public Comment

Oral comments. Staff will accept oral comments during the meeting. Comments may be limited to three minutes per speaker. Any comments may become part of the public record in this proceeding.
