Notice of Addendum to the LOCALIZED HEALTH IMPACTS REPORT

Selected Projects Awarded Funding Through the Alternative and Renewable Fuel and Vehicle Technology Program Under Solicitation PON-11-604 Publication CEC-600-2012-005-AD

The *Localized Health Impacts Report for Selected Advanced Vehicle Technology Manufacturing Projects Awarded Funding Through the Alternative and Renewable Fuel and Vehicle Technology Program under Solicitation PON-11-604* was posted on July 25, 2012, and the 30-day public comment period ended August 27, 2012.

On September 27, 2012, the California Energy Commission posted a Revised Notice of Proposed Awards resulting in additional projects proposed for funding under the Alternative Fuel Infrastructure grant solicitation PON-11-604. The Energy Commission is required under California Code of Regulations, Title 13, Chapter 8.1, Section 2343(c)(6), to consider the localized health impacts and environmental justice when approving projects for funding.

The Energy Commission has published an addendum to the original Localized Health Impacts Report that analyzes the additional projects proposed for funding under the Program. The addendum was publicly available on December 4, 2012.

The specific projects analyzed in this report are:

- Motiv Power Systems, Inc., *Pilot Production Line for Powertrain Components of Medium- and Heavy-Duty Electric Vehicles*
- Trexa LLC, *TREXA BEV M9 Pilot Production Facility and Third Party BEV Business Accelerator Facility*
- Vantage Vehicle International, Inc., *California Electric Vehicle Project*
