Summary of Item

The City of Soledad (City) has experienced project implementation delays due to limited staff resources and budgetary constraints. The City has requested Amendment 1 to extend the grant end date from October 31, 2011 to June 14, 2012 which will allow them to fully complete their approved project.

Justification for Action Requested:

The City is committed to reducing energy consumption and reduction of greenhouse gas emissions. The City now has a new staff member devoted to implement the grant. In addition, the City provided an updated implementation plan with updated milestones and due dates. This plan has been reviewed and deemed reasonable by the Commission Project Manager. Previous budgetary constraints did not allow the City to dedicate staff to the grant process. The retirement of a City employee has made funds available for the new staff member.
