**RESOLUTION: CERTIFICATION OF THE RESIDENTIAL AND NONRESIDENTIAL
COMPLIANCE MANUALS FOR THE 2013 BUILDING ENERGY EFFICIENCY STANDARDS**

WHEREAS, the 2013 Building Energy Efficiency Standards, amending California Code of Regulations, title 24, parts 1, 6, and 11, were adopted by the California Energy Commission on May 31, 2012, and were approved by the California Building Standards Commission on January 23, 2013, with an effective date of January 1, 2014, and

WHEREAS, the Warren-Alquist Act, in Public Resources Code section 25402.1, subd. (e), requires the Energy Commission to develop updated compliance manuals whenever the Commission adopts updated Building Energy Efficiency Standards, which must contain design and construction suggestions, instructions and other information to assist persons in meeting the standards, including forms, charts and other data; and

WHEREAS, Energy Commission staff has developed new content for the compliance manuals to explain the requirements of the Standards to the people that must comply with and enforce the Standards, conducted an extensive process inviting people with extensive knowledge of the Standards and interest in the updates in the 2013 Standards to review and comment on the updated compliance manuals, and revised the compliance manuals to respond to the comment that was received; and

WHEREAS, the Energy Commission commends the work of its staff, its contractors, and utility sponsors of specific provisions of the Standards, to develop the compliance manuals and revise them to respond to commenters, and commends the commenters for devoting their time to provide valued input to the Energy Commission so that the compliance manuals can be effective in facilitating efficient and successful implementation of the 2013 Standards.

THEREFORE BE IT RESOLVED, that on June 12, 2013, as required by Public Resources Code section 25402.1, subd. (e), the Energy Commission certifies:

- the Residential Compliance Manual, Document Number CEC-400-2013-001-CMF, June 2013;
- Nonresidential Compliance Manual, Document Number CEC-400-2013-002-CMF, June 2013;
- and
- associated compliance documents contained in the Manuals

used to demonstrate compliance with the 2013 Building Energy Efficiency Standards; and

THEREFORE BE IT FURTHER RESOLVED, that the Energy Commission directs the Executive Director to take, on behalf of the Commission, all actions reasonably necessary to make the above-referenced documents available and in good form, including but not limited to correcting typographical and other non-substantive errors.
