**NOTICE OF RECEIPT**  
**PETITION TO AMEND THE ENERGY COMMISSION DECISION for the**  
**CALPINE KING CITY COGEN PROJECT**  
**(85-AFC-5C)**

On April 14, Calpine King City Cogen, LLC filed a petition with the California Energy Commission requesting to modify the King City Cogen (KCC) Project. The 130-megawatt project was certified by the Energy Commission in 1987 and began commercial operation on April 28, 1989. The facility is located in the City of King City, in the County of Monterey.

**DESCRIPTION OF PROPOSED MODIFICATION**

The petition proposes to change Conditions of Certification (COCs) related to air quality that are a result of recent revisions to permits from the Monterey Bay Unified Air Pollution Control District (MBUAPCD) and to allow for performance testing as required by federal and state mandates and the Western Electricity Coordinating Council (WECC).

The proposed changes include new Conditions of Certification for the gas turbine and operational and auxiliary boilers exempting them from hourly and annual emission limits during mandated testing activities. A proposal to delete a Condition of Certification to allow multiple startups, shutdowns and operation at low loads for tuning purposes has also been requested.

**ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES**

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will subsequently be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to property owners adjacent to the project site and interested parties who may want to participate in the amendment process.
