II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund the research to determine the effect of utility scale solar installations on the soil carbon cycle in deserts and arid landscapes.

B. Problem/ Solution Statement

Problem

The Agreement will address the question of whether land alteration and modification during the construction and use of solar installations has a measurable impact on the soil carbon balance, and ultimately on the net carbon savings that solar installations provide during their lifetime. Although the questions concerning land use changes due to development of solar plants have emerged, no studies have been performed to investigate this question.

Solution

The Recipient will install soil and meteorological sensors in solar installations and in adjacent undisturbed areas to make direct comparisons on the gains or losses of carbon, the changes in microclimate and hydrology, changes in dust generation or capture, and predicted long term changes based on geochemical modeling.

C. Goals and Objectives of the Agreement

Agreement Goals

The goals of this Agreement are to:

- Measure impacts of renewable energy facilities on ground-level microclimate, plant-soil processes, and carbon dynamics relative to control sites.
- Quantify carbon fluxes in different major desert vegetation types in undisturbed and disturbed sites.
- Quantify carbon fluxes and sequestration capacity in soils with high and low caliche density in undisturbed and disturbed sites.
- Identify the environmental costs and benefits of renewable energy development in terms of greenhouse gas emissions that takes into account potential change in emissions across different vegetation and soil types, as well as avoided emissions from fossil fuels, such that the study produces a “net change” metric.
- Identify the potential effects of long-term climate change, such as to how changes in temperature, soil moisture and related factors may affect carbon cycling and carbon sequestration capacity by altering geochemical soil processes and other processes responsible for caliche formation and persistence in semi-arid environments.

Ratepayer Benefits:² This Agreement will result in the ratepayer benefits of drastically decreasing the uncertainty regarding the performance (in terms of carbon emission reductions) of utility scale solar installations. Additionally, the project will provide both empirical and model-based estimates of the impact of probable climate change on the desert soil carbon cycle and storage.

Technological Advancement and Breakthroughs:³ This Agreement will lead to technological advancement and breakthroughs to overcome barriers to the achievement of the State of California’s statutory energy goals by determining the net carbon emissions that may be reduced through the siting of utility scale solar installations in desert landscapes.

Agreement Objectives

The objectives of this Agreement are to:

- Obtain real-time information on the atmospheric and soil microclimate within, and outside of, representative solar installations in key arid landscapes.
- Obtain detailed soil chemical and isotopic measurements that will help interpret changes to the carbon cycle.
- Develop a geochemical model as an exploratory tool to address long term changes to the soil carbon cycle caused by land use or climate change.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. Products that require a draft version are indicated by marking “**(draft and final)**” after the product name in the “Products” section of the task/subtask. If “(draft and final)” does not appear after the product name, only a final version of the product is required. With respect to due dates within this Scope of Work, “**days**” means working days.

The Recipient shall:

For products that require a draft version, including the Final Report Outline and Final Report

- Submit all draft products to the CAM for review and comment in accordance with the Project Schedule (Part V). The CAM will provide written comments to the Recipient on the draft product within 15 days of receipt, unless otherwise specified in the task/subtask for which the product is required.
- Consider incorporating all CAM comments into the final product. If the Recipient disagrees with any comment, provide a written response explaining why the comment was not incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

For products that require a final version only

- Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

For all products

- Submit all data and documents required as products in accordance with the following:

- **Electronic File Format**

Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission's software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. Deliver an electronic copy of the full text of any Agreement data and documents in a format specified by the CAM, such as memory stick or CD-ROM.

The Recipient will bring its Project Manager and any other individuals designated by the CAM to this meeting. The administrative and technical aspects of the Agreement will be discussed at the meeting. Prior to the meeting, the CAM will provide an agenda to all potential meeting participants. The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The administrative portion of the meeting will include discussion of the following:

- Terms and conditions of the Agreement;
- Administrative products (subtask 1.1);
- CPR meetings (subtask 1.3);
- Match fund documentation (subtask 1.7);

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the

Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, advisory group findings and recommendations, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.

Subtask 1.4 Final Meeting

The goal of this subtask is to complete the closeout of this Agreement.

The Recipient shall:

- Meet with Energy Commission staff to present project findings, conclusions, and recommendations. The final meeting must be completed during the closeout of this Agreement. This meeting will be attended by the Recipient and CAM, at a minimum. The meeting may occur in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The technical and administrative aspects of Agreement closeout will be discussed at the meeting, which may be divided into two separate meetings at the CAM's discretion.

- The technical portion of the meeting will involve the presentation of findings, conclusions, and recommended next steps (if any) for the Agreement. The CAM will determine the appropriate meeting participants.
- The administrative portion of the meeting will involve a discussion with the CAM and the CAO of the following Agreement closeout items:
 - Disposition of any state-owned equipment.
 - Need to file a Uniform Commercial Code Financing Statement (Form UCC-1) regarding the Energy Commission's interest in patented technology.
 - The Energy Commission's request for specific "generated" data (not already provided in Agreement products).
 - Need to document the Recipient's disclosure of "subject inventions" developed under the Agreement.
 - "Surviving" Agreement provisions such as repayment provisions and confidential products.
 - Final invoicing and release of retention.

MATCH FUNDS, PERMITS, AND SUBCONTRACTS

Subtask 1.7 Match Funds

The goal of this subtask is to ensure that the Recipient obtains any match funds planned for this Agreement and applies them to the Agreement during the Agreement term.

While the costs to obtain and document match funds are not reimbursable under this Agreement, the Recipient may spend match funds for this task. The Recipient may only spend match funds during the Agreement term, either concurrently or prior to the use of Energy Commission funds. Match funds must be identified in writing, and the Recipient must obtain any associated commitments before incurring any costs for which the Recipient will request reimbursement.

The Recipient shall:

- Prepare a *Match Funds Status Letter* that documents the match funds committed to this Agreement. If no match funds were part of the proposal that led to the Energy Commission awarding this Agreement and none have been identified at the time this Agreement starts, then state this in the letter.

If match funds were a part of the proposal that led to the Energy Commission awarding this Agreement, then provide in the letter:

- A list of the match funds that identifies:
 - The amount of cash match funds, their source(s) (including a contact name, address, and telephone number), and the task(s) to which the match funds will be applied.
 - The amount of each in-kind contribution, a description of the contribution type (e.g., property, services), the documented market or book value, the source (including a contact name, address, and telephone number), and the task(s) to which the match funds will be applied. If the in-kind contribution is equipment or other tangible or real property, the Recipient must identify its owner and provide a contact name, address, telephone number, and the address where the property is located.
- A copy of a letter of commitment from an authorized representative of each source of match funding that the funds or contributions have been secured.
- At the Kick-off meeting, discuss match funds and the impact on the project if they are significantly reduced or not obtained as committed. If applicable, match funds will be included as a line item in the progress reports and will be a topic at CPR meetings.
- Provide a *Supplemental Match Funds Notification Letter* to the CAM of receipt of additional match funds.
- Provide a *Match Funds Reduction Notification Letter* to the CAM if existing match funds are reduced during the course of the Agreement. Reduction of match funds may trigger a CPR meeting.

Subtask 1.8 Permits

The goal of this subtask is to obtain all permits required for work completed under this Agreement in advance of the date they are needed to keep the Agreement schedule on track. Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

The Recipient shall:

- Prepare a *Permit Status Letter* that documents the permits required to conduct this Agreement. If no permits are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
 - A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
 - The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a *Copy of Each Approved Permit*.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

Subtask 1.9 Subcontracts

- Include any required Energy Commission flow-down provisions in each subcontract, in addition to a statement that the terms of this Agreement will prevail if they conflict with the subcontract terms.
- If required by the CAM, submit a draft of each *Subcontract* required to conduct the work

TECHNICAL ADVISORY COMMITTEE

Subtask 1.10 Technical Advisory Committee (TAC)

The goal of this subtask is to create an advisory committee for this Agreement. The TAC should be composed of diverse professionals. The composition will vary depending on interest, availability, and need. TAC members will serve at the CAM's discretion. The purpose of the TAC is to:

- Provide guidance in project direction. The guidance may include scope and methodologies, timing, and coordination with other projects. The guidance may be based on:
 - Technical area expertise;
 - Knowledge of market applications; or
 - Linkages between the agreement work and other past, present, or future projects (both public and private sectors) that TAC members are aware of in a particular area.
- Review products and provide recommendations for needed product adjustments, refinements, or enhancements.
- Evaluate the tangible benefits of the project to the state of California, and provide recommendations as needed to enhance the benefits.
- Provide recommendations regarding information dissemination, market pathways, or commercialization strategies relevant to the project products.

The TAC may be composed of qualified professionals spanning the following types of disciplines:

- Researchers knowledgeable about the project subject matter;
- Members of trades that will apply the results of the project (e.g., designers, engineers, architects, contractors, and trade representatives);
- Public interest market transformation implementers;
- Product developers relevant to the project;
- U.S. Department of Energy research managers, or experts from other federal or state agencies relevant to the project;
- Public interest environmental groups;
- Utility representatives;
- Air district staff; and
- Members of relevant technical society committees.

The Recipient shall:

- Prepare a *List of Potential TAC Members* that includes the names, companies, physical and electronic addresses, and phone numbers of potential members. The list will be discussed at the Kick-off meeting, and a schedule for recruiting members and holding

the first TAC meeting will be developed.

- Recruit TAC members. Ensure that each individual understands member obligations and the TAC meeting schedule developed in subtask 1.11.

- Prepare a *TAC Meeting Schedule* that will be presented to the TAC members during recruiting. Revise the schedule after the first TAC meeting to incorporate meeting comments.
- Prepare a *TAC Meeting Agenda* and *TAC Meeting Back-up Materials* for each TAC meeting.
- Organize and lead TAC meetings in accordance with the TAC Meeting Schedule. Changes to the schedule must be pre-approved in writing by the CAM.
- Prepare *TAC Meeting Summaries* that include any recommended resolutions of major TAC issues.

TASK 2 SITE SELECTION

The goals of this task are to (1) finalize solar installations for study and (2) conduct soil

investigations to assure site homogeneity.

The Recipient shall:

- Travel to SunPower Boulder, SunPower Rosamund, and Carrizo Plain solar study sites and work out with site managers to determine appropriate and workable sensor installations and soil sampling plans.
- Use existing soil maps and field sampling techniques to map the distribution of soil types at potential sensor installation locations.
- Prepare and provide a Report entitled “*Survey of soil properties at SunPower desert solar installations: Boulder, Rosamund, and Carrizo Plain Sites*” to include:
 - Digital elevation models and landform distribution maps,
 - Ages of landforms determined via U-series analysis,
 - Refined site soil surveys, and
 - Final site selection and installation locations.

- Survey of soil properties at SunPower desert solar installations: Boulder, Rosamund, and Carrizo Plain Sites

TASK 3 SENSOR INSTALLATIONS

The goals of this task are to (1) install and operate atmospheric and soil monitoring systems and (2) dust generation and deposition systems.

The Recipient shall:

- For each research site, purchase, test, install, and monitor commercially available sensors including:
 - Ground surface temperature, relative humidity, photosynthetically active radiation, and wind (Hobo Onset RX-3000);
 - Depth-dependent temperature, water potential (Decagon), carbon dioxide (CO₂) (Vaisala) or similar sensors.
- For each site, purchase and install stainless steel tubing at varied soil depths for collection of atmospheric samples for quarterly stable carbon and oxygen isotope analysis.
- At one site, emplace permanent, reflective cover adjacent to control plot following spring rains and install temperature and water potential (Decagon) sensors.
- At one site, install soil moisture and temperature (Decagon) sensor in and around a natural cobble on the land surface.
- For each site, purchase, construct, and install vertical and horizontal dust and sand transport collectors.
- Prepare and provide a *Sensor Installation Report* documenting sensor installation locations and publish multi-year micrometeorology data sets.

TASK 4 SOIL SAMPLING AND ANALYSES

The goals of this task are to (1) sample soils, (2) chemically and physically analyze the collected

samples, and (3) conduct field-based hydrological measurement of the research sites.

The Recipient shall:

- At each site, excavate soil trenches to depths of at least 100 cm, and collect samples by horizon and/or depth interval to maximize information about the soil processes.
- In the lab, perform soil chemical, isotopic, and physical analyses:
 - Organic carbon and nitrogen on fines,
 - Carbonate content,
 - Stable carbon and nitrogen isotope composition of soil organic matter,
 - Stable carbon and oxygen isotope composition of carbonate in fines,
 - Radiocarbon dates for subset of soil carbonate samples,
 - Soil mineralogy via X-ray diffractometry,
 - Soil water retention curves,
 - Soil porosity, and
 - Soil water permeability function.
- In the field, measure both soil saturated and unsaturated soil hydraulic conductivity (Decagon tension infiltrometers).
- Conduct a Critical Project Review as described in Subtask 1.3.
- Prepare and provide a *Soil Sampling Report* detailing sampling locations and sample types.

TASK 5 SOIL GEOHYDROLOGICAL MODELING

The goals of this task are to (1) adapt a well-known geochemical model (ToughReact) to desert soil conditions and (2) conduct model simulations over different timescales that examine both short and long term impacts of land use and climate change on the soil carbon cycle.

The Recipient shall:

- Prepare a geohydrological model of the study sites using the ToughReact modeling platform:
 - Discretize one-dimensional (1D) and two-dimensional (2D) grids representing soil physical (mineralogy, porosity) and hydrological (soil water retention curves, soil permeability) conditions with depth;
 - Define initial simulation conditions based on measured CO₂ and water content;
 - Define simulation boundary conditions as a function of depth and panel position based on measured CO₂ fluxes, micrometeorological data (rainfall event size and duration, temperature, RH), and dust deposition rate and composition.
- Perform forward numerical simulations to match initial calcium carbonate (CaCO₃) depth distribution (model calibration & validation).
- Perform numerical experiments (100 year duration) in 2D to project the evolution of the soil carbonate content with depth and net CO₂ fluxes in response to changes in boundary conditions associated with solar array emplacement.
- Perform numerical experiments (>1000 year duration) in 1D to project net CO₂ fluxes in response to long-term changes in climate (i.e. monthly and annual temperature and rainfall values).
