On September 07, 2016, the California Energy Commission (Energy Commission) released a Grant Solicitation and Application Package entitled “Natural Gas Fueling Infrastructure Application Manual” under the Alternative and Renewable Fuel and Vehicle Technology Program. This grant solicitation was an offer to fund projects that will establish or expand infrastructure necessary to store, distribute and dispense compressed natural gas for use in natural gas vehicles. The grant solicitation announced that there is a total of \$3.5 million available for the agreements resulting from this solicitation and that the Energy Commission, at its sole discretion, reserves the right to increase or reduce the amount of funds available.

The attached table, “Notice of Proposed Awards”, identifies each applicant selected and recommended for funding by Energy Commission staff and includes the amount of recommended funding and score. Funding of proposed projects resulting from this solicitation is contingent upon the approval of these projects at a publicly noticed Energy Commission Business Meeting and execution of a grant agreement.
