On November 29, 2012, the California Energy Commission (Energy Commission) released a Grant Solicitation and Application Package entitled “Natural Gas Fueling Infrastructure” under the Alternative and Renewable Fuel and Vehicle Technology Program (ARFVTP). This competitive grant solicitation was an offer to fund projects that establish infrastructure necessary to store, distribute and dispense compressed or liquefied natural gas.

The attached table, “Revised Notice of Proposed Awards”, identifies each applicant selected and recommended for funding including six additional qualified projects that did not receive funding in the earlier Notice of Proposed Awards. Due to increased funding, the Energy Commission has awarded the next projects eligible for funding. This notice is being mailed to all parties who submitted an application to this solicitation that has had a change in their results and is also posted on the Energy Commission’s website at: <http://www.energy.ca.gov/contracts/index.html>.

Funding of proposed projects resulting from this solicitation is contingent upon the approval of these projects at a publicly noticed Business Meeting at the Energy Commission in Sacramento, California, and execution of a grant agreement.
