On November 19, 2012, the California Energy Commission (Commission) released a Grant Solicitation and Application Package entitled "Hydrogen Fuel Infrastructure" under the Alternative and Renewable Fuel and Vehicle Technology Program (ARFVTP). This grant solicitation was an offer to fund projects that develop infrastructure necessary to expand the network of publicly accessible hydrogen fueling stations. The grant solicitation announced that the maximum funding available for this solicitation was \$28.59 million.

The attached table, "Notice of Proposed Awards", identifies each applicant selected and recommended for funding by Energy Commission staff and includes the amount of recommended funding and score.
