NOTICE OF PROPOSED AWARD

Renewable Energy and Conservation Planning Grants

Grant Solicitation PON-13-505

April 1, 2014

On February 12, 2014, the California Energy Commission (Energy Commission) released a Grant Solicitation and Application Package entitled "Renewable Energy and Conservation Planning Grants." This competitive grant solicitation was an offer to fund plans for the development or revisions of rules and policies that facilitate the development of eligible renewable energy resources and their associated electric transmission facilities, and the processing of permits for eligible renewable energy resources.

The grant solicitation announced that there is up to \$1.5 million available for the resulting agreements. The maximum award amount per agreement is \$400,000. The Energy Commission must complete environmental review under CEQA and approve each grant at a business meeting prior to the applicable encumbrance deadline. Thus, if a project cannot complete CEQA review in time to meet the applicable encumbrance deadline, the Energy Commission reserves the right to cancel the proposed award and recommend funding to the next highest scoring award that can meet the encumbrance deadline.



Funding of proposed projects resulting from this solicitation is contingent on approval at a publicly noticed Business Meeting at the Energy Commission in Sacramento, California, execution of a grant agreement, and providing a Memorandum of Understanding signed by the grant award recipient and the Energy Commission as specified in Public Resource Code Section 25619(b)(2). The encumbrance deadline for these agreements is June 30, 2014.
