## SEVENTH REVISED NOTICE OF PROPOSED AWARD

### Alternative and Renewable Fuel and Vehicle Technology Program

#### Grant Solicitation PON-13-607

#### Hydrogen Refueling Infrastructure – Operation and Maintenance Grants

**August 9, 2016**

On November 22, 2013, the California Energy Commission (Energy Commission) released a Grant Solicitation and Application Package entitled “Hydrogen Refueling Infrastructure” under the Alternative and Renewable Fuel and Vehicle Technology Program (ARFVTP). This grant solicitation (PON-13-607) was an offer to fund projects: 1) to develop infrastructure necessary to dispense hydrogen transportation fuel; and 2) to provide needed Operation and Maintenance (O&M) funding to support hydrogen refueling operations prior to the large-scale roll-out of Fuel Cell Electric Vehicles (FCEVs). Funding will be provided to construct, upgrade, or support hydrogen refueling stations that expand the network of publicly accessible hydrogen refueling stations to serve the current population of FCEVs and accommodate the planned large-scale roll-out of FCEVs commencing in 2016.

On March 28, 2014, the Energy Commission issued a Notice of Proposed Awards (NOPA) for O&M support grants to 4 hydrogen stations that were operational. On October 17, 2014, the Energy Commission issued a Revised NOPA for 2 additional stations that became operational; on June 11, 2015, the Energy Commission issued a Second Revised NOPA for 9 stations; on August 24, 2015, the Energy Commission issued a Third Revised NOPA for 13 stations; on September 29, 2015, the Energy Commission issued a Fourth Revised NOPA for 4 stations and 1 mobile refueler; on December 15, 2015, the Energy Commission issued a Fifth Revised NOPA for 11 additional stations; and on February 23, 2016, the Energy Commission issued a Sixth Revised NOPA for 1 additional station. The attached Seventh Revised NOPA is for the 2 additional stations.

As articulated in PON-13-607 funding for these grants is tied to the date the station becomes operational, as follows:
