**NOTICE OF PROPOSED AWARD (NOPA)**

**Market Analysis of Trends in California Investor-Owned Utility
Electricity Load Shapes
RFP-15-322
May 24, 2016**

On April 18, 2016, the California Energy Commission released a competitive solicitation to fund market analysis to characterize existing and future electricity load in the service territories of Pacific Gas and Electric Company, Southern California Edison Company, and San Diego Gas & Electric Company. Up to \$2 million in Electric Program Investment Charge (EPIC) funding is available for this solicitation.

The Energy Commission received five proposals by the due date of May 6, 2016. The proposals were screened, reviewed, evaluated and scored using the criteria in the solicitation.

The attached "Notice of Proposed Award" identifies the Bidder that is recommended for funding by Energy Commission staff and includes the recommended funding amount and score. The total amount recommended is \$1,147,406.00.

Funding of the proposed project resulting from this solicitation is also contingent upon the approval of the project at a publicly noticed Energy Commission Business Meeting and execution of a contract agreement. If the Energy Commission is unable to timely execute a contract with the Bidder, the Energy Commission, at its sole discretion, reserves the right to cancel or otherwise modify the pending award.
