MEETING WITH CALTRANS REGARDING CECP AND OTHER PROJECTS

On July 3, 2008, I attended a meeting with other city staff and Caltrans held at the City's Faraday Center. The meeting's purpose was to discuss various projects along I-5 in Carlsbad, including the Carlsbad Energy Center Project (CECP), which would be affected by the planned I-5 widening. Caltrans representatives attending are listed below.

At the meeting, Carlsbad staff made it clear that the city did not support the CECP in its currently proposed location at the Encina Power Station. Caltrans representatives noted their agency has been in discussion with NRG about the proposal and has sent electronic plans to NRG. Representatives also commented that the proposed I-5 widening is a well known project, citing the release of the I-5 widening NOP/NOI in 2004 and, I believe, the project's inclusion in the SANDAG Regional Transportation Plan.

Caltrans staff indicated the widening will clip the northeast corner of the CECP perimeter road and also noted that Caltrans would not be mitigating for visual impacts. However, there was discussion at the meeting about landscaping which the agency typically does for highway projects. Further, Caltrans staff expressed interest in potential safety issues resulting from any CECP hazardous equipment or materials located close to I-5. Due to the potential hazards, representatives noted that Caltrans may require heavier duty walls to separate freeway traffic from the CECP, and suggested that such improvements may be the responsibility of NRG to construct.

I also mentioned that recently NRG had indicated it would be revising the CECP to include a taller stack, new switchyard location, and a desal plant and also indicated those changes may affect the CECP site plan. I also noted that the California Energy Commission is behind in its review of this project, partly because of project changes and the complexity of the issues associated with the CECP.


