Subject: **COMMUNITY POWER PROJECT (07-AFC-7) STATUS REPORT #4**

Pursuant to direction from the Hearing Officer dated June 23, 2008, the following is Energy Commission staff's Status Report #4 for the proposed Community Power Project (CPP).

Staff has been working through the analysis phase of the Application for Certification (AFC) process for the proposed CPP.

- The applicant has not responded fully to Round #1 Data Requests, filed on January 23, 2008. Data Requests are still outstanding for Biology, Cultural Resources, Land Use, Waste Management, and Water Resources. Biological, Cultural, and Hazardous Waste surveys and studies are still in progress. The applicant states the additional data responses (Set 1C) will be forthcoming in August 2008.
- The applicant has indicated that an AFC Supplement B will be filed in August 2008, which will include minor transmission line reroutes and a new 60-acre construction staging area. The Alternatives Level Analysis of the PG&E transmission line reconductoring (response to Data Request #52) and Phase I Environmental Site Assessment (ESA) for the natural gas and water pipeline routes will also be submitted at that time. Staff anticipates that a second round of data requests will be needed to address the proposed project changes, reconductoring analysis, and Phase I ESA.
- The applicant states the San Joaquin Air Pollution Control District does not expect to issue a Preliminary Determination of Compliance (PDOC) until late fall 2008. Staff anticipates the Preliminary Staff Assessment would be issued at least 30-45 days following receipt of the PDOC.
