I. NOTICE OF AVAILABILITY

II. NOTICE OF SUPPLEMENTAL EVIDENTIARY HEARING

PLEASE TAKE NOTICE that the Committee has scheduled a Supplemental Evidentiary Hearing to reopen the record and to receive evidence as follows:

As indicated in the PMPD, we will reopen the record at the Supplemental Evidentiary Hearing for the limited purpose of taking evidence on the issues specified below:

AIR QUALITY. Applicant and Staff shall consult with the California Air Resources Board (CARB) to identify and implement the appropriate modeling protocol to ensure that the project complies with the new state NO₂ standard (adopted March 20, 2008), which lowered the existing 1-hour-average standard for NO₂ of 0.25 ppm to 0.18 ppm, not to be exceeded, and established a new annual-average standard of 0.030 ppm, not to be exceeded.

PUBLIC HEALTH. Applicant and Staff shall provide evidence regarding the relevance of new ambient air quality data from CARB's March 18, 2008, Draft Health Risk Assessment on diesel particulate emissions in the Oakland area for the purpose of characterizing ambient air quality in the East Bay for the risk assessment required by Condition **PUBLIC HEALTH-1**.

WORKER SAFETY AND FIRE PROTECTION. No mitigation is proposed to address Staff's preliminary finding that the *project's incremental effect on fire and emergency response would be cumulatively considerable*. Although the Hayward Fire Department (HFD) did not provide information on the costs of upgrading Opticom, the HFD's failure to respond does not obviate the project's potential cumulative impact on HFD services. We believe this impact must be mitigated. The Applicant, Staff, and City of Hayward are directed to draft a Condition of Certification to resolve this issue.

PROCEDURE

During the Supplemental Evidentiary Hearing, all parties (Applicant, Staff, and Intervenor, if applicable) shall present evidence consisting of declarations or sworn testimony in person, and exhibits for each topic area. The parties must identify their witnesses and submit their prepared written testimony in the form of sworn declarations by the date indicated below. All witnesses who appear in person shall testify under oath or affirmation and are subject to cross-examination by other parties.

The parties shall file and serve copies of their prepared written testimony and proposed exhibits no later than **5 p.m. Tuesday, July 15, 2008**. The parties shall also send electronic copies of their written testimony and exhibits to the Proof of Service list via e-mail and additional copies to the Hearing Officer in MS Word format.


- Amtrak:** Exit at the Hayward Station. Take A.C. Transit bus #92 to the BART station, approximately six blocks away.
- BART:** Exit at the Hayward Station, walk one block east, along Civic Center Plaza.
- Peninsula:** Take the Hayward-San Mateo Bridge (CA-92) east towards Hayward. CA Highway 92 becomes Jackson St, continue east to Watkins St. Turn left onto Watkins St. The Hayward Civic Center and Plaza is at the corner of Watkins and B St.

North Bay (using I-880): Take I-880 South, exit at A St and at the end of the ramp, turn left onto A St. Continue east on A St, towards the hills, to Grand St. Turn right onto Grand St and then turn left onto B St. The Hayward Civic Center and Plaza is at the corner of Watkins and B St.

South Bay (using I-880): Take I-880 North, exit at A St and at the end of the ramp, turn right onto A St. Continue east on A St, toward the hills, to Grand St. Turn right onto Grand St and then turn left onto B St. The Hayward Civic Center and Plaza is at the corner of Watkins and B St.
