The Old Spanish Trail Association (OSTA) is a partner of the Nat'l Park Service and the BLM in the protection, preservation and interpretation of the Old Spanish Nat'l Historical Trail. Early portions of the trail run immediately south of the project site and may, in fact, cross part of the HHSEGS project. Since 2007, OSTA has been locating and recording segments of the OST between Tecopa, CA, and the Nevada state line. 
