PURPOSE OF EVIDENTIARY HEARINGS

The purpose of Evidentiary Hearings is to establish the factual record necessary for the Commission to reach a decision on the proposed project. The record is developed by the presentation of oral and written testimony, as well as documentary evidence, submitted by the parties. Evidentiary Hearings are more structured than the informal workshops and Committee Conferences that have already occurred. The parties must identify their witnesses and submit their testimony in writing prior to the hearings. Witnesses will testify under oath or affirmation and will be subject to cross-examination by other parties who have formally intervened in this case.

Pursuant to Government Code, section 11445.10 et seq. and section 1217 of the Commission's regulations, the Committee may conduct all or portions of the evidentiary hearings in an informal manner in which, for example but not by way of limitation, a panel of witnesses sponsored by a single party or by multiple parties testify at one time, with an exchange of questions and responses between the witnesses and counsel for the various parties substituting for formal direct and cross-examination.

The Applicant has the burden of presenting sufficient substantial evidence to support the findings and conclusions required for certification of the site and related facilities. (Cal. Code of Regs., tit. 20, § 1748(e).)

Public Adviser and Public Participation

Members of the public are welcome to attend and offer comments at the Prehearing Conference and at the Evidentiary Hearings. It is not necessary to be an Intervenor to participate in the public process. Comments may also be submitted in writing. 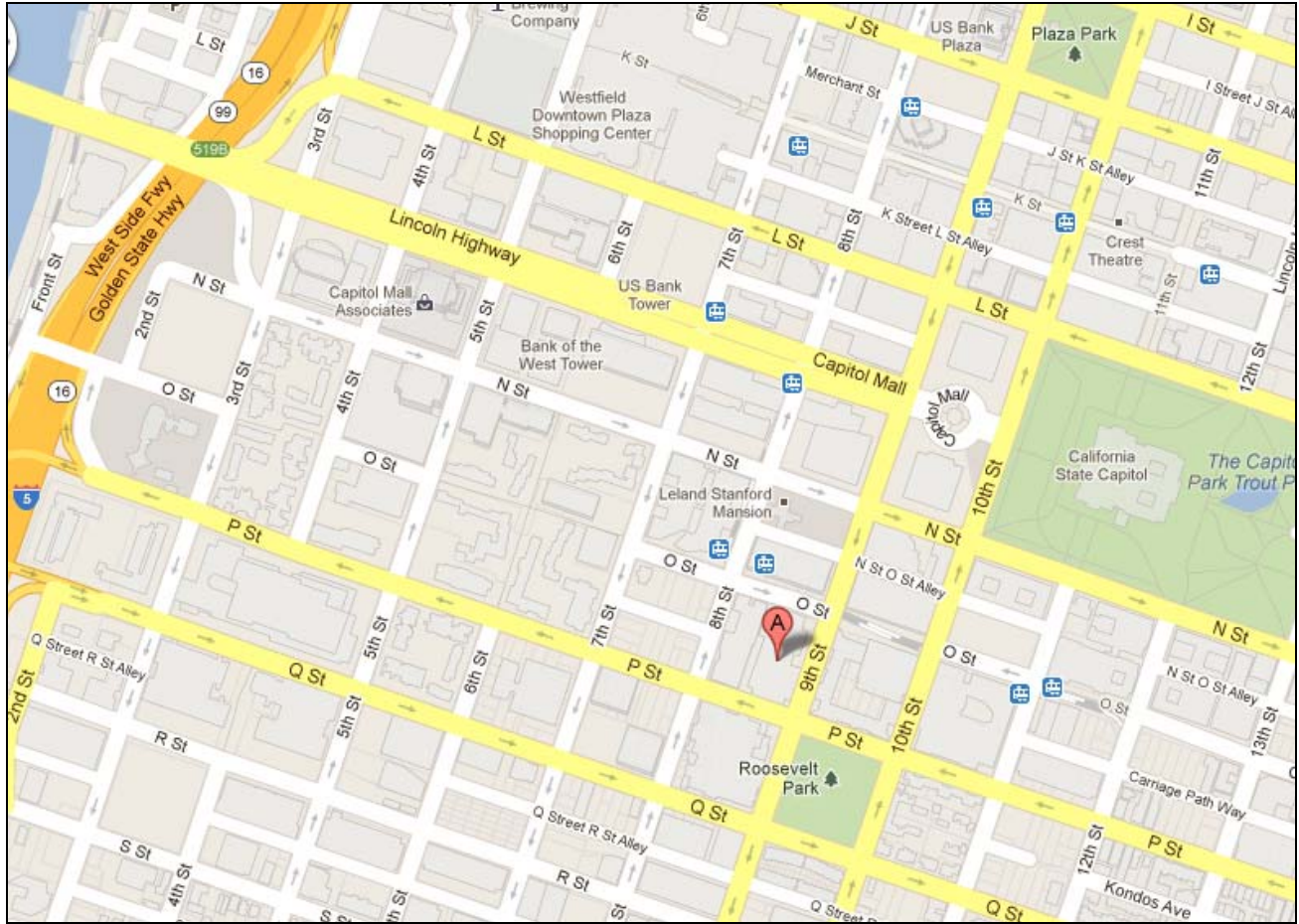
