Chair Alvord moved to approve the annual report from the Energy Commission and Board Member Lloyd seconded the motion. The motion passed 5-0.*
6. PRESENTATION AND POSSIBLE VOTE ON ANNUAL REPORT FROM THE CALIFORNIA COMMUNITY COLLEGE CHANCELLOR'S OFFICE. (Hoang Nguyen, California Community College Chancellor's Office)  
*California Community College Chancellors Office staff member Hoang Nguyen presented to the Board the Proposition 39 Clean Energy Jobs Act 2017-18 summary report. Vice Chair Martinez moved to approve the report. Chair Alvord seconded the motion. The motion passed 5-0.*
