**NOTICE OF PROPOSED AWARD (NOPA)****The EPIC Challenge: Accelerating the Deployment of
Advanced Energy Communities (Phase II)****GFO-15-312****January 29, 2019**

On May 18, 2018, the California Energy Commission (Energy Commission) released a competitive solicitation to fund a competition that will challenge project teams comprised of building developers, local governments, technology developers, researchers, utilities, and other project partners to develop innovating and replicable approaches for accelerating the deployment of Advanced Energy Communities. Up to \$30 million in Electric Program Investment Charge (EPIC) funding is available to fund applications in Groups 5 to 8.

- Group 5: Advanced Energy Community; Northern California Build Out
- Group 6: Advanced Energy Community; Southern California Build Out
- Group 7: Disadvantaged Community; Northern California Build Out
- Group 8: Disadvantaged Community; Southern California Build Out

The Energy Commission received nine proposals by the due date of September 21, 2018. Each proposal was screened, reviewed, evaluated and scored using the criteria in the solicitation. All nine proposals passed the Stage One Application Screening.

The attached "Notice of Proposed Awards" identifies each applicant selected and recommended for funding by Energy Commission staff and includes the recommended funding amount and score. The total amount recommended is \$9,999,060.

There is not a proposed award for Groups 7 or 8. A solicitation will be re-issued for those groups only.

Funding of proposed projects resulting from this solicitation is contingent upon the approval of these projects at a publicly noticed Energy Commission Business Meeting and execution of a grant agreement. If the Energy Commission is unable to timely negotiate and execute a funding agreement with an Applicant, the Energy Commission, at its sole discretion, reserves the right to cancel or otherwise modify the pending award, and award the funds to another applicant.

In addition, the Energy Commission reserves the right to: 1) add to, remove, or shift funding between the different groups if there are insufficient passing proposals in one group and 2) negotiate with successful applicants to modify the project scope, schedule, and/or level of funding.
