On March 9, 2017, the California Energy Commission released a competitive solicitation to select one contractor to perform education, outreach, and facilitation.

The awardee will perform statewide education and outreach for the AB 802 benchmarking and disclosure program, facilitate energy-related workforce and industry alignment, and facilitate an energy efficiency collaborative as directed by the 2015 Existing Buildings Energy Efficiency Action Plan and the 2016 Action Plan Update.

Up to \$1 million in funding is available for this solicitation. Of this amount, \$500,000 is immediately available. The remaining balance may be available contingent upon approval of funds for fiscal year 2017-2018.

The Energy Commission received five proposals by the due date of April 11, 2017. The proposals were screened, reviewed, evaluated, and scored using the criteria in the solicitation.

The attached "Notice of Proposed Award" identifies the Bidder that is recommended for funding by Energy Commission staff and includes the recommended funding amount and score. The total amount recommended is \$931,936.91.

Funding of the proposed project resulting from this solicitation is also contingent upon the approval of the project at a publicly noticed Energy Commission Business Meeting and execution of a contract agreement. If the Energy Commission is unable to timely execute a contract with the Bidder, the Energy Commission, at its sole discretion, reserves the right to cancel or otherwise modify the pending award.
