## Background

The Audits, Investigations, and Program Review (AIPR) Office conducts audits of Energy Commission grant recipients to ensure the expenditures claimed for the grant and as match are allowable, supported, and incurred within the approved time period, and to verify the products and deliverables detailed in the grant agreement's scope of work are completed as required.

If a grant recipient is audited and the audit generates audit findings, the Energy Commission will request specific actions of the recipient to resolve the findings, which could include repayment of funds. This workshop will provide information on common audit findings found among Energy Commission grants and will provide recommendations for accounting and record-keeping practices that recipients can put in place to minimize or avoid audit findings.


## Muting
