INSTITUTE OF GAS TECHNOLOGY. Proposed resolution approving Agreement PIR-17-009 with the Institute of Gas Technology for a \$1,499,381 grant to develop a natural gas, plug-in, hybrid-electric drayage truck using a whole-system approach to controls design to optimally balance major subsystems over critical duty cycles. The vehicle will use a near-zero emission natural gas engine in a parallel hybrid configuration to improve performance while dramatically reducing emissions and maximizing fuel economy.

Research will be conducted at FEV and GTI. The various hybrid vehicle subsystems will be integrated at US Hybrid onto an existing truck platform.

Demonstration activities will be conducted at UC Riverside's existing chassis dynamometer facility. The truck will be installed onto the dynamometer to perform several duty cycles. Data will be collected from the dynamometer testing and analyzed.

II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund the development and demonstration of a fully integrated and optimized natural gas, hybrid-electric Class 8 vehicle.

B. Problem/ Solution Statement

Problem

Real world testing of heavy-duty hybrid vehicles performed by UC Riverside, California Air Resources Board, the National Renewable Energy Laboratory, and others has shown that the vehicles are consistently not meeting goals and often are increasing nitrogen oxides (NOx) without improving fuel economy. This is largely because most hybrid controls in the Class 8 sector have not matured to have an integrated vehicle propulsion energy management solution.

Solution

The key focus of this project is to develop an integrated vehicle energy management control architecture that will provide new perspective to propulsion system controls. The solution developed in this work can easily be implemented in future commercial projects.

C. Goals and Objectives of the Agreement

Agreement Goals

The goal of this Agreement is to develop and demonstrate an optimized engine, hybrid, and vehicle controller system on a natural gas hybrid-electric Class 8 truck that can effectively manage driver demands and improve overall system performance and emissions.

Ratepayer Benefits: This Agreement will result in the ratepayer benefits of lower costs, environmental benefits, public health, consumer appeal, and energy security by developing an optimized Class 8 natural gas, hybrid-electric truck. The project will advance the current state-of-the-art matching and packaging of the natural gas engine and the electric motor/generator/storage components at lower incremental capital cost, with better fuel economy, improved service and drivability, while lowering GHG and criteria pollutants such as NOx. The project will also expand business opportunities and continue the growth of California-based clean transportation technology firms, jobs, and businesses to the support the further development and production of hybrid-electric trucks.

Technological Advancement and Breakthroughs: This Agreement will lead to technological advancement and breakthroughs to overcome barriers to the achievement of the State of California's statutory energy goals by developing an efficient energy management platform that controls engine and hybrid energy sources in meeting vehicle propulsion needs.

Agreement Objectives

The objectives of this Agreement are to:

- Optimize the controls of the hybrid-electric vehicle by taking a holistic approach to controlling all vehicular sub-systems including the hybrid drivetrain, the engine, and emissions after-treatment system.
- Develop and apply technology to an existing hybrid Class 8 truck platform with an electric drive system, lithium ion battery, and an electric drive motor in a parallel hybrid configuration.
- Integrate a state-of-the-art, near-zero NOx certified, production natural gas engine with a hybrid drivetrain.
- Demonstrate the emissions and performance improvements on a chassis dynamometer.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. Products that require a draft version are indicated by marking “**(draft and final)**” after the product name in the “Products” section of the task/subtask. If “(draft and final)” does not appear after the product name, only a final version of the product is required. With respect to due dates within this Scope of Work, “**days**” means working days.

The Recipient shall:

- Submit all draft products to the CAM for review and comment in accordance with the Project Schedule (Part V). The CAM will provide written comments to the Recipient on the draft product within 15 days of receipt, unless otherwise specified in the task/subtask for which the product is required.
- Consider incorporating all CAM comments into the final product. If the Recipient disagrees with any comment, provide a written response explaining why the comment was not incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

For products that require a final version only

- Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

For all products

- Submit all data and documents required as products in accordance with the following:

Instructions for Submitting Electronic Files and Developing Software:

- **Electronic File Format**
 - Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission’s software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, advisory group findings and recommendations, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

Subtask 1.4 Final Meeting

The Recipient shall:

TECHNICAL ADVISORY COMMITTEE

Subtask 1.10 Technical Advisory Committee (TAC)

- Recruit TAC members. Ensure that each individual understands member obligations and the TAC meeting schedule developed in subtask 1.11.
- Prepare a *List of TAC Members* once all TAC members have committed to serving on the TAC.
- Submit *Documentation of TAC Member Commitment* (such as Letters of Acceptance) from each TAC member.

 - Power management
 - Regenerative braking development
 - Basic battery charge/discharge strategy
 - Communication with high voltage battery
 - Communication with high voltage inverter
 - Communication with DC/DC Controls
 - P2 clutch control
 - Coolant pump control
- Implement diagnostics and safety software systems.
- Perform initial system integration testing and modeled system optimization, calibration, and validation leading to selection of final optimized platform.
