THE REGENTS OF THE UNIVERSITY OF CALIFORNIA (UC RIVERSIDE). Proposed resolution approving Agreement EPC-16-030 with The Regents of the University of California, on behalf of the Riverside campus for a \$1,783,118 grant to fund research and testing of technologies that improve energy efficiency at the server, data center, and data center cluster levels in a smart power distribution system. These technologies have the potential to reduce electrical consumption of data centers by approximately 35% through improved scheduling and workload management.

Cal. Code Regs., tit. 14, sect. 15301 provides that projects which consist of the operation repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, and which involve negligible or no expansion of use beyond that existing at the time of the lead agency's determination, are categorically exempt from the provisions of the California Environmental Quality Act. This project will involve the development and installation of experimental control systems to manage data center energy consumption. This equipment consists of small electrical controls, computer hardware, computer servers, and monitoring equipment and will not require any modification to the existing building. Therefore, this project will have no significant effect on the environment and falls within section 15301.

Code Regs., tit. 14, sect. 15306 provides that projects which consist of basic data collection, research, experimental management, and resource evaluation activities which do not result in a serious or major disturbance to an environmental resource are categorically exempt from the provisions of the California Environmental Quality Act. The majority of this project will be software-based and will apply algorithms and software to the data centers in the San Jose State University facility. Therefore, this project will have no significant effect on the environment and falls within section 15306.

II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund research and testing of technologies that could improve data center energy efficiency at three different levels in a smart power distribution system.

B. Problem/ Solution Statement

Problem

Data centers annually consume an estimated 2% (100 billion kWh) of total U.S. electricity with a cost of around \$10 billion. The peak demand of data centers represents over 2% of peak load in California and is expected to grow 4% annually in the next ten years. Therefore, it is critical to develop energy efficiency technologies for data centers in California.

Solution

The Recipient will develop technologies designed to improve energy efficiency of data centers at three levels: server level, data center level, and data center cluster level. Coordinated deep sleep and dynamic voltage-frequency scaling (DVFS), peak efficiency scheduling,

computational and electrical load migration, and spatial workload scheduling techniques will be developed and validated in a real world data center testing environment.

C. Goals and Objectives of the Agreement

Agreement Goals

The goals of this Agreement are to:

- Improve energy efficiency of data centers at the server level, data center level, and data center cluster level; and
- Limit carbon footprint of data centers

Ratepayer Benefits:² This Agreement could result in the ratepayer benefits of greater electricity reliability, lower costs, and increased safety by migrating load across data centers with consideration of electricity price, cost of data migration, carbon-footprint, renewable energy integration and operating condition of the distribution network.

- Greater electricity reliability will be achieved by reducing the amount of electricity required of servers in idle.
- Lower data center operating costs will be achieved through the reduction of electricity used and through the minimal hardware required for use of energy-saving software.
- Increased safety will be achieved through reducing the amount of electricity used during peak hours. Thus, the risk of equipment failure, such as transformers overheating, will be reduced.

Benefits to ratepayers will also be achieved by balancing the load across power distribution phases by migrating load across racks in data centers, and by improving energy efficiency through peak efficiency scheduling and coordinating deep sleep and DVFS to lower electricity costs to ratepayers.

Technological Advancement and Breakthroughs:³ This Agreement could lead to technological advancement and breakthroughs to overcome barriers to the achievement of the State of California's statutory energy goals by:

1. Providing energy efficiency technology and software solutions to data center industry to facilitate the implementation of the CPUC's Energy Efficiency Strategic Plan,
2. Reducing electricity consumption of data centers by approximately 35% of the data center's usage by using data center energy efficiency technology to address the emission reduction goals specified in AB32 and Executive Order B-30-15, and
3. Producing qualified data center and power engineers mentioned in the Governor's Clean Energy Jobs Plan 2011.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. Products that require a draft version are indicated by marking “**(draft and final)**” after the product name in the “Products” section of the task/subtask. If “(draft and final)” does not appear after the product name, only a final version of the product is required. With respect to due dates within this Scope of Work, “**days**” means working days.

The Recipient shall:

For products that require a draft version, including the Final Report Outline and Final Report

- Submit all draft products to the CAM for review and comment in accordance with the Project Schedule (Part V). The CAM will provide written comments to the Recipient on the draft product within 15 days of receipt, unless otherwise specified in the task/subtask for which the product is required.
- Consider incorporating all CAM comments into the final product. If the Recipient disagrees with any comment, provide a written response explaining why the comment was not incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

For products that require a final version only

- Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

For all products

- Submit all data and documents required as products in accordance with the following:

Instructions for Submitting Electronic Files and Developing Software:

o **Electronic File Format**

- Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission’s software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. Deliver an electronic copy of the full text of any Agreement data and documents in a format specified by the CAM, such as memory stick or CD-ROM.

Subtask 1.2 Kick-off Meeting

The goal of this subtask is to establish the lines of communication and procedures for implementing this Agreement.

The Recipient shall:

- Attend a "Kick-off" meeting with the CAM, the Commission Agreement Officer (CAO), and any other Energy Commission staff relevant to the Agreement. The Recipient will bring its Project Manager and any other individuals designated by the CAM to this meeting. The administrative and technical aspects of the Agreement will be discussed at the meeting. Prior to the meeting, the CAM will provide an agenda to all potential meeting participants. The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The administrative portion of the meeting will include discussion of the following:

- o Terms and conditions of the Agreement;
- o Administrative products (subtask 1.1);
- o CPR meetings (subtask 1.3);
- o Match fund documentation (subtask 1.7);
- o Permit documentation (subtask 1.8);
- o Subcontracts (subtask 1.9); and

The technical portion of the meeting will include discussion of the following:

- o The CAM's expectations for accomplishing tasks described in the Scope of Work;
 - o An updated Project Schedule;
 - o Technical products (subtask 1.1);
 - o Progress reports and invoices (subtask 1.5);
 - o Final Report (subtask 1.6);
 - o Technical Advisory Committee meetings (subtasks 1.10 and 1.11); and
 - o Any other relevant topics.
- Provide an *Updated Project Schedule, List of Match Funds, and List of Permits*, as needed to reflect any changes in the documents.

The CAM shall:

- Designate the date and location of the meeting.
- Send the Recipient a Kick-off Meeting Agenda.

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, advisory group findings and recommendations, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.

- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).

The CAM shall:

If the CAM concludes that satisfactory progress is not being made, this conclusion will be referred to the Deputy Director of the Energy Research and Development Division.
- Provide the Recipient with a *Progress Determination* on continuation of the project, in accordance with the schedule. The Progress Determination may include a requirement that the Recipient revise one or more products.

Subtask 1.4 Final Meeting

This meeting will be attended by the Recipient and CAM, at a minimum. The meeting may occur in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The technical and administrative aspects of Agreement closeout will be discussed at the meeting, which may be divided into two separate meetings at the CAM's discretion.

- The technical portion of the meeting will involve the presentation of findings, conclusions, and recommended next steps (if any) for the Agreement. The CAM will determine the appropriate meeting participants.
- The administrative portion of the meeting will involve a discussion with the CAM and the CAO of the following Agreement closeout items:

Subtask 1.6: Final Report

The CAM will review the Final Report, which will be due at least **two months** before the Agreement end date. When creating the Final Report Outline and the Final Report, the Recipient must use the Style Manual provided by the CAM.

Subtask 1.7 Match Funds

The goal of this subtask is to ensure that the Recipient obtains any match funds planned for this Agreement and applies them to the Agreement during the Agreement term.

While the costs to obtain and document match funds are not reimbursable under this Agreement, the Recipient may spend match funds for this task. The Recipient may only spend match funds during the Agreement term, either concurrently or prior to the use of Energy Commission funds.  - The amount of cash match funds, their source(s) (including a contact name, address, and telephone number), and the task(s) to which the match funds will be applied.
 - The amount of each in-kind contribution, a description of the contribution type (e.g., property, services), the documented market or book value, the source (including a contact name, address, and telephone number), and the task(s) to which the match funds will be applied. If the in-kind contribution is equipment or other tangible or real property, the Recipient must identify its owner and provide a contact name, address, telephone number, and the address where the property is located.
 - A copy of a letter of commitment from an authorized representative of each source of match funding that the funds or contributions have been secured.
- At the Kick-off meeting, discuss match funds and the impact on the project if they are significantly reduced or not obtained as committed. If applicable, match funds will be included as a line item in the progress reports and will be a topic at CPR meetings.
- Provide a *Supplemental Match Funds Notification Letter* to the CAM of receipt of additional match funds.
- Provide a *Match Funds Reduction Notification Letter* to the CAM if existing match funds are reduced during the course of the Agreement. Reduction of match funds may trigger a CPR meeting.

Subtask 1.8 Permits

The goal of this subtask is to obtain all permits required for work completed under this Agreement in advance of the date they are needed to keep the Agreement schedule on track. Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

The Recipient shall:

- Prepare a *Permit Status Letter* that documents the permits required to conduct this Agreement. If no permits are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
 - o A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
 - o The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.
