Proposed resolution approving Agreement FPI-19-011 with Bimbo Bakeries USA, Inc. for a \$1,142,695 grant to install a waste heat recovery system, high efficiency motors, and replacement boilers at multiple Bimbo Bakeries facilities to reduce natural gas and electricity consumption and GHG emissions, and adopting staff's determination that this action is exempt from CEQA. Explain reason why Agreement is exempt under the above section: This project will install waste heat recovery equipment and more efficient motors at Bimbo Bakeries Sacramento location and replace existing boilers with smaller boilers in Placentia, Montebello, and Escondido bakeries. This project will involve minor

alteration of existing mechanical equipment at an existing food processing facility and will result in negligible or no expansion of the existing use. The materials used to construct the system are chemically inert, not hazardous to human health, and do not have a significant effect on the environment. The systems purchased have safety certifications in compliance with relevant codes and standards. In addition, all required permits for installation and operation of the system will be obtained prior to system installation and demonstration. The demonstrations will not have a significant impact on local air quality, noise, or traffic, and is expected to reduce local criteria pollutant emissions. For these reasons, the project will not have a significant effect on the environment and falls under the categorical exemption listed in 14 C.C.R.15301.

This project involves the construction, location, and installation of new, small facilities, structures, and equipment. In order to perform the demonstration, the system must be installed at the demonstration site. The installation will require minimal construction activity. The equipment will be placed adjacent to the facility on existing concrete pads. It is possible additional small concrete pads will be poured. This minimal construction is well within the size limits listed in the examples given in 14 C.C.R. 15303 (e.g., it is less than a single-family residence, duplex, and the 2,500 square feet - or 10,000 square feet in urban areas - for a store, motel, office, restaurant, or similar structure). This construction will not have a significant impact on local air quality, noise, or traffic and will not induce additional operations at the site. For these reasons, the project will not have a significant effect on the environment and falls under the categorical exemption listed in 14 C.C.R. 15303.

II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund the installation of energy efficient industrial baking equipment across four Bimbo facilities, including waste heat recovery, boilers, and motors. The natural gas and electricity consumption of affected equipment will be measured before and after installation to verify energy savings.

B. Problem/ Solution Statement

Problem

On-site industrial emissions represent about one-quarter of California's overall greenhouse gas emissions. There is significant scope to reduce consumption of natural gas by food processors through more efficient boilers and related equipment like economizers and waste heat recovery. The indirect greenhouse gas emissions from electricity can also be mitigated through more efficient industrial equipment. However, businesses cannot justify the large upfront costs of equipment upgrades without sufficient demonstration and verification of benefits.

Solution

The Recipient will procure, install, and demonstrate a thermal oxidizer waste heat recovery system, new boilers, and improved motors. The energy and fuel cost saved by these new systems will be measured. The verification of fuel and maintenance cost reductions of these new systems will demonstrate the benefits of energy efficiency to facilities using similar equipment.

C. Goals and Objectives of the Agreement

Agreement Goal

The goal of this Agreement is to reduce natural gas and electricity consumption at the Recipient's baking facilities.

Agreement Objectives

The objectives of this Agreement are to:

- Install a waste heat capture system to the bakery's oxidizer and recover that heat in the existing heat and steam processes at the Recipient's Sacramento facility.
- Replace aging, inefficient gas boilers with low-emission, higher-efficiency boilers.
- Replace standard controlled electric motors with more efficient units.
- Reduce electricity consumption by at least 300,000 kWh and natural gas consumption by 300,000 therms annually.
- Measure electricity and natural gas consumption of affected equipment before and after installation to validate energy savings.
- Disseminate the results of the project to other food processors.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. The Recipient will bring its Project Manager and any other individuals designated by the CAM to this meeting. The administrative and technical aspects of the Agreement will be discussed at the meeting. Prior to the meeting, the CAM will provide an agenda to all potential meeting participants. The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The administrative portion of the meeting will include discussion of the following:

- o Terms and conditions of the Agreement;
- o Administrative products (subtask 1.1);
- o CPR meetings (subtask 1.3);
- o Match fund documentation (subtask 1.6);
- o Permit documentation (subtask 1.7);
- o Subcontracts (subtask 1.8); and
- o Any other relevant topics.

The technical portion of the meeting will include discussion of the following:

- o The CAM's expectations for accomplishing tasks described in the Scope of Work;
 - o An updated Project Schedule;
 - o Technical products (subtask 1.1);
 - o Progress reports and invoices (subtask 1.5);
 - o Final Report (subtask 1.6); and
 - o Any other relevant topics.
- Provide an *Updated Project Schedule*, *List of Match Funds*, and *List of Permits*, as needed to reflect any changes in the documents.

The CAM shall:

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.
- Send the Recipient a *CPR Agenda* and a *List of Expected CPR Participants* in advance of the CPR meeting. If applicable, the agenda will include a discussion of match funding and permits.
- Conduct and make a record of each CPR meeting. Provide the Recipient with a *Schedule for Providing a Progress Determination* on continuation of the project.
- Determine whether to continue the project, and if so whether modifications are needed to the tasks, schedule, products, or budget for the remainder of the Agreement. If the CAM concludes that satisfactory progress is not being made, this conclusion will be referred to the Deputy Director of the Energy Research and Development Division.

Subtask 1.7 Match Funds

Subtask 1.8 Permits

Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

The Recipient shall:

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a *Copy of Each Approved Permit*.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

 - o Ensure installation of sub-metering equipment and data loggers for pre/post data analysis.
- Prepare and provide a detailed *M&V Plan* for each project demonstration site to include but not be limited to:
 - o A description of the monitoring equipment and instrumentation which will be used.
 - o A description of the key input parameters and output metrics which will be measured.
