Proposed resolution approving Agreement EPC-19-010 with Lawrence Berkeley National Laboratory for a \$2,000,000 grant to develop and test a high-resolution optic sensing system for real-time monitoring of offshore wind turbine operations and marine animal activities, and adopting staff's determination that this action is exempt from CEQA for phase 1 of this project. Phase 1 focuses on developing and testing the fiber optic sensing system at lab scale. A possible phase 2 field demonstration is subject to future Energy Commission approval

simulate an offshore wind turbine. The test apparatus will be used to develop sensor technology based on Rayleigh and Brillouin backscattering that will not result in any measurable change to the environment.

If field testing is conducted, it too, will only entail minor alterations to existing structures by installing small sensors on existing wind turbines. Any collected data will be transferred wirelessly and not through the installation of cables or other physical connecting devices between the sensors and data collection site. No environmental changes will occur with the installation or use of the sensors.

II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund fiber optic sensing for real time monitoring of offshore wind turbine (OWT) operations and marine animal activities.

EXHIBIT A Scope of Work Lawrence Berkeley National Laboratory B. Problem/ Solution Statement

Problem

Gearbox failure is the most common in wind turbines, and tower is fundamental to OWT in natural hazard prone coast of California. In addition, marine animal activity monitoring is critically important for environmentally sustainable development of OWTs. Despite the importance of real time monitoring of operation and marine animal activities there is a lack of advanced technologies that can provide the capabilities needed for OWT in California.

Solution

The Recipient will develop a novel fiber optical sensing (FOS) system for real time and continuous monitoring of gearbox, tower operations, and marine mammal activities near OWTs based on three-dimensional strain, vibration and temperature. This approach provides critical datasets to allow (1) real time monitoring of OWT operational condition and diagnostic signal of potential malfunctions to allow effective operation management that can significantly reduce O&M costs, and (2) real time monitoring of OWT developments on marine life.

C. Goals and Objectives of the Agreement

Agreement Goals

The goals of this Agreement are to:

- Develop an integrated FOS system coupling Brillouin and Rayleigh scattering technologies for OWT monitoring
- Analyze data from the developed FOS system which includes but is not limited to, OWT real time monitoring of gearbox operations, tower status, and marine animal activities.

<u>Ratepayer Benefits</u>:² This Agreement will result in the ratepayer benefits of greater electricity reliability, lower costs, and increased safety by providing real time monitoring capability to track operation status, and diagnose pre-failure signs that can be used to (1) reduce O&M cost, and (2) trigger emergency management to minimize chances of catastrophic events.

<u>Technological Advancement and Breakthroughs</u>:³ This Agreement will lead to technological advancement and breakthroughs to overcome barriers to the achievement of the State of California's statutory energy goals by enabling real time OWT gearbox and tower operation and marine animal activities monitoring, which can lead to reduced O&M cost, reduced LCOE, greater OWT reliability and safety, and promote environmental sustainability.

Agreement Objectives

The objectives of this Agreement are to:

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a Copy of Each Approved Permit.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.
