II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND **OBJECTIVES**

A. Purpose of Agreement

The purpose of this Agreement is to fund energy efficient upgrades that reduce natural gas consumption and greenhouse gas (GHG) emissions at the Recipient's biofuels and animal food production facility.

B. Problem/ Solution Statement

Problem

The margins for food production are quite tight. As a result, producers often operate plants continuously for long periods, shutting down only on rare occasion for maintenance or vital repairs. Upgrading existing and functional systems with the addition of energy efficient equipment, therefore, often not a high priority for food production plant operators and typically does not occur until the end of useful lifetime for existing equipment or systems. For these reasons, the Recipient has not made the proposed additions of energy efficient equipment to its biofuels and animal food production facility.

Today, however, California is striving to achieve aggressive reductions in GHG emissions through a variety of policy and carbon pricing mechanisms. Food producers in California are responsible

for numerous metric tons of carbon-dioxide equivalent (MT CO₂e) emissions per year, and represent a significant opportunity to reduce GHG emissions.

Solution

The Recipient will retrofit and replace inefficient equipment with commercially available, drop-in, high efficiency equipment which reduces energy consumption, operating costs, and GHG emissions at the Recipient's biofuels and animal food production facility. Specifically, equipment related to the distillation and evaporation process will be installed which significantly reduces natural gas consumption. In doing so, this project will demonstrate the potential to significantly reduce GHG emissions at food processing and other industrial facilities with large distillation systems.

C. Goals and Objectives of the Agreement

Agreement Goals

The goals of this Agreement are to reduce GHG emissions and energy consumption by implementing energy efficient upgrades at the biofuels and animal food production facility.

Agreement Objectives

The objectives of this Agreement are to:

- Measure the facility's electricity and natural gas consumption in order to establish a baseline for future comparisons.
- Install approximately drop-in, commercially available equipment related to the distillation and evaporation sections of the facility.
- Increase production of animal feed wet distiller's grains by at least 20 percent to 537,600 tons per year.
- Increase production of animal feed distiller's corn oil by at least 20 percent to 7,680 tons per year.
- Reduce annual natural gas consumption by at least 60 percent approximately equivalent to 7.1 million therms.
- Reduce facility GHG emissions by at least 35 percent approximately equivalent to 23,700 MT CO2e/year.
- Distribute \$30,000 in scholarships to students from low-income or disadvantaged communities.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V).** Products that require a draft version are indicated by marking "(draft and final)" after the product name in the "Products" section of the task/subtask. If "(draft and final)" does not appear after the product name, only a final version of the product is required. With respect to due dates within this Scope of Work, "days" means working days.

For products that require a draft version, including the Final Report Outline and Final Report

- Submit all draft products to the CAM for review and comment in accordance with the Project Schedule (Part V). The CAM will provide written comments to the Recipient on the draft product within 15 days of receipt, unless otherwise specified in the task/subtask for which the product is required.
- Consider incorporating all CAM comments into the final product. If the Recipient disagrees
 with any comment, provide a written response explaining why the comment was not
 incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

For products that require a final version only

 Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

For all products

Submit all data and documents required as products in accordance with the following:

Instructions for Submitting Electronic Files and Developing Software:

Electronic File Format

Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission's software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. Deliver an electronic copy of the full text of any Agreement data and documents in a format specified by the CAM, such as memory stick or CD-ROM.

The following describes the accepted formats for electronic data and documents provided to the Energy Commission as products under this Agreement, and establishes the software versions that will be required to review and approve all software products:

Project Manager and any other individuals designated by the CAM to this meeting. The
administrative and technical aspects of the Agreement will be discussed at the meeting.
Prior to the meeting, the CAM will provide an agenda to all potential meeting participants.
The meeting may take place in person or by electronic conferencing (e.g., WebEx), with
approval of the CAM.

The <u>administrative portion</u> of the meeting will include discussion of the following:

- o Terms and conditions of the Agreement;
- Administrative products (subtask 1.1);
- CPR meetings (subtask 1.3);
- Match fund documentation (subtask 1.6);
- Permit documentation (subtask 1.7);
- Subcontracts (subtask 1.8); and
- Any other relevant topics.

The technical portion of the meeting will include discussion of the following:

- o The CAM's expectations for accomplishing tasks described in the Scope of Work;
- o An updated Project Schedule;
- Technical products (subtask 1.1);
- Progress reports and invoices (subtask 1.5);
- o Final Report (subtask 1.6); and
- Any other relevant topics.
- Provide an Updated Project Schedule, List of Match Funds, and List of Permits, as needed to reflect any changes in the documents.

The CAM shall:

- Designate the date and location of the meeting.
- Send the Recipient a Kick-off Meeting Agenda.

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.
- Send the Recipient a CPR Agenda and a List of Expected CPR Participants in advance
 of the CPR meeting. If applicable, the agenda will include a discussion of match funding
 and permits.
- Conduct and make a record of each CPR meeting. Provide the Recipient with a Schedule for Providing a Progress Determination on continuation of the project.
- Determine whether to continue the project, and if so whether modifications are needed to the tasks, schedule, products, or budget for the remainder of the Agreement. If the CAM concludes that satisfactory progress is not being made, this conclusion will be referred to the Deputy Director of the Energy Research and Development Division.

• Provide the Recipient with a *Progress Determination* on continuation of the project, in accordance with the schedule. The Progress Determination may include a requirement that the Recipient revise one or more products.

This meeting will be attended by the Recipient and CAM, at a minimum. The (meeting may occur in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The technical and administrative aspects of Agreement closeout will be discussed at the meeting, which may be divided into two separate meetings at the CAM's discretion.

- The technical portion of the meeting will involve the presentation of findings, conclusions, and recommended next steps (if any) for the Agreement. The CAM will determine the appropriate meeting participants.
- The administrative portion of the meeting will involve a discussion with the CAM and the CAO of the following Agreement closeout items:
 - Disposition of any state-owned equipment.
 - Need to file a Uniform Commercial Code Financing Statement (Form UCC-1) regarding the Energy Commission's interest in patented technology.
 - The Energy Commission's request for specific "generated" data (not already provided in Agreement products).
 - Need to document the Recipient's disclosure of "subject inventions" developed under the Agreement.
 - "Surviving" Agreement provisions such as repayment provisions and confidential products.
 - Final invoicing and release of retention.

Subtask 1.7 Match Funds

The goal of this subtask is to ensure that the Recipient obtains any match funds planned for this Agreement and applies them to the Agreement during the Agreement term.

While the costs to obtain and document match funds are not reimbursable under this Agreement, the Recipient may spend match funds for this task. The Recipient may only spend match funds during the Agreement term, either concurrently or prior to the use of Energy Commission funds. Match funds must be identified in writing, and the Recipient must obtain any associated commitments before incurring any costs for which the Recipient will request reimbursement.

The Recipient shall:

Prepare a Match Funds Status Letter that documents the match funds committed to this

If the in-kind contribution is equipment or other tangible or real property, the Recipient must identify its owner and provide a contact name, address, telephone number, and the address where the property is located.

- At the Kick-off meeting, discuss match funds and the impact on the project if they are significantly reduced or not obtained as committed. If applicable, match funds will be included as a line item in the progress reports and will be a topic at CPR meetings.

- Provide a Match Funds Reduction Notification Letter to the CAM if existing match funds are reduced during the course of the Agreement. Reduction of match funds may trigger a CPR meeting.

Subtask 1.8 Permits

The goal of this subtask is to obtain all permits required for work completed under this Agreement in advance of the date they are needed to keep the Agreement schedule on track. Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

- Prepare a Permit Status Letter that documents the permits required to conduct this Agreement. If no permits are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
 - A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
 - o The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a Copy of Each Approved Permit.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

Subtask 1.9 Subcontracts

- Include any required Energy Commission flow-down provisions in each subcontract, in addition to a statement that the terms of this Agreement will prevail if they conflict with the subcontract terms.
- If required by the CAM, submit a draft of each *Subcontract* required to conduct the work under this Agreement.
- Submit a final copy of the executed subcontract.
- Notify and receive written approval from the CAM prior to adding any new subcontractors (see the discussion of subcontractor additions in the terms and conditions).

IV. TECHNICAL TASKS

Products that require a draft version are indicated by marking "(draft and final)" after the product name in the "Products" section of the task/subtask. If "(draft and final)" does not appear after the product name, only a final version of the product is required. **Subtask 1.1 (Products)** describes the procedure for submitting products to the CAM.

TASK 2: SITE PREPARATION AND EQUIPMENT PROCUREMENT

The goal of this task is to procure the necessary equipment and materials for the installation of drop-in, commercially available, energy efficient equipment.

The Recipient shall:

- Procure equipment by:
 - o Discussing equipment, electrical, and installation requirements with potential California-based vendors.
 - o Finalizing equipment specifications.
 - Preparing equipment list. For each item, the list shall provide the name of the item and make, model, size, capacity or other information as appropriate to the item. Items may include, as necessary:
 - Additional evaporator stages;
 - Additional mash column;
 - Heat exchangers;
 - Electric pumps and motors;
 - Electrical panels and other upgrades:
 - Mechanical vapor recompression units;
 - Insulation for holding tanks and pipes;
 - Measurement and Verification (M&V) sensors and related equipment;
 - Machine to machine communications for automation; and
 - Plant automation software with artificial intelligence.
 - Issuing bid documents, reviewing responses, and selecting California-based vendors.
 - Placing equipment orders in a staggered fashion to correspond with proposed installation timeline.
- Secure all necessary permits required for installation and operation of all equipment.
- Prepare proposed locations at the site for installation of the new equipment. Steps include:
 - Preparing the installation timeline.
 - o Identifying drop sites for new equipment.
 - Accept delivery of new equipment at chosen drop sites.
- Provide a Site Preparation and Equipment Procurement Memo that shall include, but not be limited to:
 - Summary of the steps to prepare the site;
 - Copy of the performance specifications for each piece of equipment purchased by the grant;
 - Summary of the bids received and from whom;
 - Copies of all required permits needed for installation;
 - Status of the planned installation including preliminary schedule for equipment delivery and installation for each site; and
 - Copies of Equipment List and Installation Timeline.

TASK 3: EQUIPMENT INSTALLATION

The goal of this task is to install the necessary equipment for this project, to start up and commission it, and to resume normal plant operations.

- Execute installation of the project as outlined in the installation timeline and equipment list. Install each piece of equipment or group of equipment as follows:
 - · Shut down plant processes as required;
 - Uninstall existing version(s) of equipment;
 - Install new equipment;
 - Install M&V meters and equipment;
 - Conduct pre-startup safety review;
 - Perform cold commissioning, which will include:
 - Completion and system check out; and
 - Confirmation of operational readiness.
 - Perform hot commissioning, which will include:
 - Performance testing of new systems;
 - Performance testing of integration with existing food production system;
 - Performing test run of production; and
 - Optimize system performance in response to testing in order to meet stated performance specification.
- Provide an Equipment Installation Memo that shall include, but not be limited to:
 - Summary of the equipment installation requirements;
 - Identification of barriers involved during installation and discuss the steps taken to overcome those barriers;
 - Discuss results of equipment start-up and commissioning with respect to whether the equipment as installed meets the stated performance specifications.
- Prepare a CPR Report #1 in accordance with subtask 1.3.
- · Participate in a CPR Meeting.

TASK 4: MEASUREMENT AND VERIFICATION

The goal of this task is to report the benefits resulting from this project. The project team will use a third-party vendor for M&V of GHG and energy consumption reduction.

- Enter into agreement with M&V subcontractor per Task 1.9
- Coordinate site visits with the M&V subcontractor at the demonstration site
- Develop M&V protocol for pre-installation measurements (and calculations):
 - Electric, natural gas and/or other fossil fuel consumption and GHG emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation) of the equipment/process/system(s)/sub-system(s) that are to be upgraded and/or replaced and/or modified.
 - Ensure installation of sub-metering equipment and data loggers for pre/post data analysis.
- Prepare and provide a detailed *M&V Plan* to include but not be limited to:
 - A description of the monitoring equipment and instrumentation which will be used.
 - A description of the key input parameters and output metrics which will be measured.
 - A description of the M&V protocol and analysis methods to be employed.

- A description of the independent, third-party M&V services to be employed, if applicable.
- Perform three months (or shorter period as approved in writing by the CAM) of preinstallation measurements (and calculations) based on the M&V protocol for preinstallation.
- Prepare and provide a *Pre-Installation M&V Findings Report* that includes M&V protocol, pre-install measurements (and calculations), analysis, and results performed in this task.
- Develop M&V protocol for post-installation measurements (and calculations) of:
 - Electric, natural gas and/or other fossil fuel consumption and GHG emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation) of the equipment/process/system(s)/sub-system(s) that will be upgraded and/or replaced and/or modified.
- Perform 12 months (or shorter period as approved in writing by the CAM) of postinstallation measurements based on M&V protocol for post-installation.
- Provide a summary of post-installation M&V progress in Progress Report(s) (see subtask
 1.5) which shall include but not be limited to:
 - A narrative on operational highlights from the reporting period, including any stoppages in operation and why; and
 - A summary of M&V findings from the reporting period.
- Analyze post-installation electrical, natural gas and/or other fossil fuel consumption and GHG emissions.
- Prepare and provide a Post-Installation M&V Findings Report that includes M&V protocol, pre and post install measurements (and calculations), analysis, and results performed in this task. Results should at a minimum report on the reduction of electricity, natural gas and/or other fossil fuel usage and reductions of GHG emissions that directly result from this project, and include the following:
 - All key assumptions used to estimate and determine energy and GHG reductions (and additions, if applicable).
 - All key assumptions used to estimate projected benefits, including targeted market sector (e.g., population and geographic location), projected market penetration, baseline and projected energy use and cost, operating conditions, and emission reduction calculations.
 - Discuss whether the energy and GHG reduction goals in section II.C were met.
- Prepare a CPR Report #2 in accordance with subtask 1.3.
- Participate in a CPR Meeting.
