Summary

Proposition 39

- 23 districts given extension
- 16 districts moved forward
- \$5.8 M remaining from project savings
- \$5.1 M used for projects

Energy Usage

- 7.3 percent reduction in energy usage across the system
 - 52 districts reported energy usage data
 - 19 districts have increased their energy usage
 - 20 districts have not reported
