CAMPBELL SOUP SUPPLY COMPANY L.L.C.. Proposed resolution approving agreement FPI-20-007 with Campbell Soup Supply Company L.L.C. for a \$899,588.00 grant to retrofit an existing double effect evaporator, used to make tomato paste, and by adding an additional effect at the Recipient's tomato processing facility. This will entail the addition of a new evaporator vessel, pumps, modifications to existing structural platforms, vapor lines, condensate piping systems, and electrical and controls. The new high efficiency system will support the company's sustainability goals, reduce operating costs, improve energy efficiency, and reduce GHG emissions.

The project will retrofit existing inefficient equipment at existing food processing facility to reduce energy consumption and greenhouse gas emissions. Site preparation includes drilling and concrete work. An existing evaporator system will be retrofitted at the Recipient's tomato processing facility. These installations will be minor alterations of existing facilities and mechanical equipment with no expansion beyond the existing use of the food processing facility and will not have significant effect on the environment. The project falls under categorical exemption listed in 14 C.C.R. §15301.

II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to retrofit an existing double-effect evaporator system with a third effect to significantly increase its efficiency at the Recipient's tomato processing facility in Dixon, CA. This project will result in greenhouse gas (GHG) emissions reductions by providing more evaporation capacity using the same amount of steam heating input, thereby making the process more efficient. The new high efficiency system will reduce operating costs, improve energy efficiency, and reduce GHG emissions.

B. Problem/ Solution Statement

Problem

Evaporation is one of the fundamental processing steps undertaken by all California tomato processors. Evaporation involves boiling off large quantities of water to concentrate tomato juice into tomato paste, reducing its volume and making it suitable to be stored and transported to various end markets. The evaporation process is inherently an energy-intensive process.

Solution

A double effect evaporator uses the heat in evaporate exhaust from the first heater, or first effect, to heat the incoming material prior to the evaporation chamber, thereby reducing the energy needed to raise the temperature of the water in the material to the boiling point. The addition of a third effect heater would utilize the heat stored in the exhaust of the second effect heater and further reduce energy requirements for the overall process.

C. Goals and Objectives of the Agreement

Agreement Goals

The goal of this Agreement is to:

- Reduce the GHG and criteria pollutant (direct and indirect) emissions by optimizing an existing evaporator system at the Recipient's tomato processing facility.

Agreement Objectives

The objectives of this Agreement are to:

- Convert an existing double effect evaporator into a triple effect evaporator by adding a third effect. This will improve evaporation efficiency and lower GHG emissions associated with steam production in the natural gas fired boilers.
- Measure the facility's natural gas consumption in order to establish a baseline for future comparisons.
- Specify and procure the necessary equipment and materials for the optimized evaporator system.
- Reduce annual natural gas consumption associated with the evaporator system by at least 250,000 therms and GHG emission by approximately 1,500 metric tons of carbon dioxide equivalent.
- Share the knowledge gained, project results, and lessons learned with relevant industry and public.

III. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

- Submit all data and documents required as products in accordance with the following:

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.
- Send the Recipient a *CPR Agenda* and a *List of Expected CPR Participants* in advance of the CPR meeting. If applicable, the agenda will include a discussion of match funding and permits.
- Conduct and make a record of each CPR meeting. Provide the Recipient with a *Schedule for Providing a Progress Determination* on continuation of the project.
- Determine whether to continue the project, and if so whether modifications are needed to the tasks, schedule, products, or budget for the remainder of the Agreement. Subtask 1.8 Permits

Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

The Recipient shall:

- Prepare a *Permit Status Letter* that documents the permits required to conduct this Agreement. If no permits are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
 - A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
 - The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be

discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a *Copy of Each Approved Permit*.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.
