Agreement will not cause direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment because the proposed site is at an existing compressed natural gas (CNG) bus storage and maintenance property that currently fuels CNG buses; the proposed addition of a hydrogen refueling facility will not significantly expand the use beyond that already existing; and the square footage of equipment installation is small, the project falls within section 15301 and will not have a significant effect on the environment.

The proposed project also consists of installation of small new equipment, including hydrogen storage, compression, and dispensing equipment at the site.
