Proposed resolution approving Amendment 2 to Agreement ARV-19-032 with Cajon Valley Union School District to augment the budget by \$100,000, extend the term of the Agreement by 24 months, and add special terms and conditions due to the new term extending beyond the liquidation deadline for the original funds, and adopting staff's determination that this action is exempt from CEQA. The budget augmentation of \$100,000 is so the school district can procure its previously awarded electric school bus and is necessary because ongoing supply chain issues have substantially increased the cost to manufacture electric school buses.
