This project will involve minor alteration of existing facilities and mechanical equipment at an existing food processing facility and will result in negligible or no expansion of the existing use. The electric roasters will directly replace the existing roaster at the facility. The systems purchased have safety certifications in compliance with relevant codes and standards. In addition, all required permits for installation and operation of the system will be obtained prior to system installation and demonstration. The demonstrations will not have a significant impact on local air quality, noise, or traffic, and is expected to reduce local criteria pollutant emissions. For these reasons, the project will not have a significant effect on the environment and falls under the categorical exemption listed in 14 C.C.R. sect 15301.

This project involves the replacement of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced. The electric coffee roasters will replace existing coffee roasters at the existing coffee roasting facility. For these reasons, the project will not have a significant effect on the environment and falls under the categorical exemption listed in 14 C.C.R sect 15302.

This project does not involve impacts on any particularly sensitive environment; any cumulative impacts of successive projects of the same type in the same place that might be considered significant; does not involve unusual circumstances that might have a significant effect on the environment; will not result in damage to scenic



resources within a highway officially designated as a state scenic highway; the project site is not included on any list compiled pursuant to Government Code section 65962.5, and the project will not cause a substantial adverse change in the significance of a historical resource. II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

A. Purpose of Agreement

The purpose of this Agreement is to fund the replacement of traditional natural gas-powered coffee roasters with electric coffee roasters at the Recipient's coffee processing facility. The project will reduce greenhouse gas (GHG) emissions and other criteria air pollutant emissions from the facility.

B. Problem/ Solution Statement

Problem

Traditional coffee roasters are reliant on fossil fuels (typically natural gas) and produce significant GHG emissions and other air pollutants produced as a byproduct of the coffee roasting process. Coffee roasting contributes to around 15% of the overall carbon footprint of coffee.² These roasters typically use a single-pass system that intakes fresh air from outside the roaster and flash-heats it to roast the coffee beans. This hot air, which includes particulates and volatile organic compounds (VOCs) such as nitrogen dioxide and methane, is then released as exhaust through ventilation stacks, while GHG emissions are emitted through fuel combustion.

Solution

The Recipient will install and demonstrate the use of electric roasters to eliminate a significant amount of emissions that result from the coffee roasting process. An electric roaster removes the use of fossil gas in coffee processing and relies instead on grid electricity, which at times is powered with 100 percent renewable energy. The electric roaster eradicates smoke, VOCs, and particulate exhaust by taking exhausted air, cleaning it, and reusing it. Also, eliminating the necessity of additional ventilation or afterburner that was previously required. Electric roasts have the potential to reduce the carbon footprint of the roast cycle by up to 92% compared with a traditional gas-powered roaster, with the final carbon reduction varying depending on the fuel composition of the local energy grid.

C. Goals and Objectives of the Agreement

Agreement Goals

The goals of this Agreement are to demonstrate the reliability and effectiveness of advanced energy equipment and a reduction of GHG emissions other criteria air pollutants by installing electric roasters at the Recipient's coffee processing facility.

Agreement Objectives

The objectives of this Agreement are to:

- Establish an energy and emissions baseline for the facility for post-project comparison.
- Specify and procure the necessary equipment and materials for the electric roasters.
- Install up to 16 electric coffee roasters to replace the existing fleet of natural gas-powered coffee roasters.
- Reduce GHG emissions by at least 500 metric tons of carbon dioxide equivalent annually.
- Benefit priority populations by reducing on-site criteria air pollutants through the reduction of fossil gas consumption and other exhaust air improvements.
- Measure and verify the pre and post gas and electricity consumption and GHG emissions, energy cost savings and overall economics resulting from using the electric roasters
- Share the knowledge gained, project results, and lessons learned with relevant industries and the public.

I. TASK 1 GENERAL PROJECT TASKS

PRODUCTS

Subtask 1.1 Products

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. - Consider incorporating all CAM comments into the final product. If the Recipient disagrees with any comment, provide a written response explaining why the comment was not incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

 Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

• Submit all data and documents required as products in accordance with the following:

<u>Instructions for Submitting Electronic Files and Developing Software:</u>

Electronic File Format

Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the California Energy Commission's (CEC) software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. The Recipient will bring its Project Manager and any other individuals designated by the CAM to this meeting. The administrative and technical aspects of the Agreement will be discussed at the meeting. Prior to the meeting, the CAM will provide an agenda to all potential meeting participants. The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The administrative portion of the meeting will include discussion of the following:

- Terms and conditions of the Agreement;
- Invoicing and auditing procedures;
- Administrative products (subtask 1.1);
- CPR meetings (subtask 1.3);
- Match fund documentation (subtask 1.7);
- Permit documentation (subtask 1.8);

Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive CEC funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the CEC and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, advisory group findings and recommendations, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient and may include the CAO and any other individuals selected by the CAM to provide support to the CEC.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit.

However, the CAM may schedule additional CPR meetings as necessary. CPR meetings generally take place at the CEC, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

The Recipient shall:

 of the Agreement toward achieving its goals and objectives; and (2) includes
 recommendations and conclusions regarding continued work on the project.
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.
- Send the Recipient a CPR Agenda with a list of expected CPR participants in advance of the CPR meeting. If applicable, the agenda will include a discussion of match funding and permits.

- Prepare a Permit Status Letter that documents the permits required to conduct this Agreement. If <u>no permits</u> are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
 - A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
 - o The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a Copy of Each Approved Permit.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

 - Ensure installation of sub-metering equipment and data loggers for pre/post data analysis.
- Prepare and provide a detailed M&V Plan for project demonstration site to include but not be limited to:
 - o A description of the monitoring equipment and instrumentation which will be used.
 - A description of the key input parameters and output metrics that will be measured.

- Develop M&V protocol for post-installation measurements (and calculations) of:
 - Electric, natural gas and/or other fossil fuel consumption and GHG emissions (use appropriate emissions factor from Attachment 9 of the grant solicitation) of the equipment/process/system(s)/sub-system(s) that will be upgraded and/or replaced and/or modified
- Perform at least 12 months (or a shorter period as approved in writing by the CAM) of post-installation measurements based on M&V protocol for post-installation.
- Provide a summary of post-installation M&V progress in Progress Report(s) (see subtask
 1.5) which shall include but not be limited to:
 - A narrative on operational highlights from the reporting period, including any stoppages in operation and why; and

- Analyze post-installation electrical, natural gas and/or other fossil fuel consumption and GHG emissions.

- Provide all key assumptions used to estimate projected benefits, including targeted market sector (e.g., population and geographic location), projected market penetration, baseline and projected energy use and cost, operating conditions, and emission reduction calculations.
