Scope of Work

PURPOSE

The purpose of this agreement is to fund the California Energy Commission's (CEC) membership as a Founding and Premier Member of Veloz, a California nonprofit organization.

BACKGROUND:

Veloz is a California-based nonprofit organization, founded by industry veterans to bring public and private sectors together to advance the electric car market. It builds off of the momentum generated by the successful California Plug-in Electric Vehicle Collaborative (Collaborative), which was a multi-stakeholder, public-private effort that worked to ensure a strong and enduring transition to a plug-in electric vehicle market in California. Like the Collaborative, Veloz brings together elected and appointed officials, automakers, utilities, infrastructure providers, environmental organizations, municipalities, transportation network companies, and others. Veloz programs, such as their annual "Electric For All" statewide multimedia awareness and education campaign, advance consumer adoption of electric vehicles by driving viewers to the brand neutral ElectricForAll.org car shopping tool, federal/state/local/utility incentive finder. public/home charging resources, and various zero-emission vehicle (ZEV) education modules. Veloz's mission is that the future of transportation is electric for all. To ensure their reach to all, Veloz has historically dedicated up to 50 percent of its campaign media buying in California's priority communities; i.e., disadvantaged, low income, and minority neighborhoods.

As a member of Veloz, the CEC will be part of forward-thinking discussions to raise public awareness and promote the benefits of driving electric vehicles. Electrification of the transportation sector, which accounts for nearly 40 percent of statewide greenhouse gas emissions, is a key California strategy to meeting its ambitious climate change policies. Thus, it is critical that the CEC contribute its expertise and energy to this effort. Veloz's mission is consistent with California's energy and environmental policies.

SCOPE OF WORK:

The CEC will pay a membership fee of \$100,000 during fiscal year 2023/2024. The fee provides the CEC membership in Veloz, which includes the following benefits to CEC:

- CEC will receive briefings on, and have input regarding, Veloz's electric vehicle awareness campaign.
- Veloz will work with the CEC Commission Agreement Manager and CEC Media
 Office to prominently display the CEC logo on Veloz's public facing electric
 vehicle awareness campaign literature and displays at the CEC's discretion.

- Attendance at exclusive member briefings with prominent policy and industry leaders.
- Acknowledgement at Veloz's public events, with prominent branding, and when appropriate a company asset (e.g., electric car, charging station, company product or non-advertising materials) on display.
- Acknowledgement in Veloz communications, insider initiatives, upcoming actions, industry news and networking opportunities.
- A leadership role in meetings/forums.
- A leadership role in working groups, workshops, webinars and networking opportunities.
- A listing, with logo, as a Premier Member on the Veloz.org website.
- A number of complimentary passes to leading industry events hosted by Veloz.
- Receipt of communications on Veloz initiatives, industry news and networking opportunities.
