The total sponsorship amount of \$5,000 is consistent with prior co-sponsorship agreements with IREC. Sponsorship rates are based on the fact that California is very large and very expensive to survey. California's solar market is the largest in the country and its workforce represents nearly 30% of the entire U.S. solar jobs market. Thus, this pricing is commensurate with the level of effort required to produce statistically significant data points at the granular level for such an enormous state. The CEC's contribution helps ensure that California leaders use IREC's highest quality numbers in understanding market drivers and potential for an important growing sector of the economy.

## <u>PURPOSE</u>

The purpose of this agreement is to formalize the California Energy Commission's sponsorship of the *National Solar Jobs Census 2022*. The Interstate Renewable Energy Council's *Solar Jobs Census Report* is the most rigorous survey-based count of solar workers in the United States. First conducted in 2010, it is considered the definitive resource on solar jobs. The Interstate Renewable Energy Council will publish an in-depth factsheet on solar jobs in California to accompany the release of the report.
