KARUK TRIBE. Proposed resolution approving agreement TCA-24-004 with Karuk Tribe for a \$200,000 grant and adopting staff's determination that this action is exempt from the California Environmental Quality Act (CEQA). The Karuk Tribe will focus on restoring traditional food sources to Karuk community gathering areas in Karuk Aboriginal Territory. Karuk staff will gather seed and grow plants in a traditional food nursery at the Tishaniik Tribal Farm, identifying which traditional foods will thrive in the low elevation river climate at the farm, and how those plants can be returned to burned areas and tended to survive into maturity. This project is covered by the Common Sense Exemption under 14 CCR 15061 (b) (3) that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.

The proposed project consists of small-scale nursery production of native plants which will be grown from seed and small soil samples collected by hand from select sites throughout Karuk Ancestral Territory. The nursery will be on the existing Tishaniik Tribal Farm, which has been in operation by the Karuk Tribe since 2020. The seed and soil-collecting sites, requiring no to minimal disturbance, will be from properties that are already active restoration sites. All proposed project activities will be on a small fee-title parcel owned by the Karuk Tribe.

In order for the CEC to comply with CEQA, the CEC must evaluate any impacts to land within the jurisdiction of the State of California, which is therefore limited to potential off-reservation impacts of the project. This project is exempt under the "common sense" CEQA exemption because the proposed project will not:



- construct on or alter any off-reservation land;
- impact local air quality;
- use groundwater resources or otherwise impact any off-reservation water resources;
- build additional transportation infrastructure;
- · increase vehicle miles traveled;
- increase ambient noise beyond the existing activities; or
- degrade the visual character or quality of off-reservation views, including those of scenic resources or objects of aesthetic significance.

Because the proposed project does not provide for any physical changes outside of the Karuk Tribe's reservation, it can be seen with certainty that there is no possibility that the proposed project may have a significant effect on the off-reservation environment. Based on all these factors, the proposed project meets the CEQA "common sense" exemption.

The project will not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; does not involve any cumulative impacts of successive projects of the same type in the same place that might be considered significant; does not involve unusual circumstances that might have a significant effect on the environment; will not result in damage to scenic resources within a highway officially designated as a state scenic highway; the project site is not included on any list compiled pursuant to Government Code section 65962.5; and the project will not cause a substantial adverse change in the significance of a historical resource. Therefore, none of the exceptions to categorical exemptions listed in CEQA Guidelines section 15300.2 apply to this project and this project will not have a significant effect on the environment.

The overall purpose of this project is to bring Karuk Traditional Ecological Knowledge (TEK) into the restoration of landscapes and native plant food sources, and to explore how that TEK can be applied to environments that have already been dramatically altered by impacts from climate change, namely catastrophic wildfires. Examples of foods that will potentially be chosen are Indian potatoes, elderberries, Native blackberries, and sugar pines.
