



Authority & Process




- Warren-Alquist Act signed into law in 1974
- Grants CEC authority to update Building Energy Efficiency Standards
- Also provides CEC authority to update voluntary standards within CALGreen
 - Appendix A4.2 Residential Voluntary Measures, Energy Efficiency
 - Appendix A5.2 Nonresidential
 Voluntary Measures, Energy Efficiency

Increase energy efficiency for residential and nonresidential buildings beyond Energy Code requirements by:

- Introducing new standards for existing buildings
- Amending and expanding standards for newly constructed buildings

Alterations to Single-Family Space Conditioning Systems

Summary of Measure Proposal:

- Prescriptive requirement for a heat pump when replacing an airconditioner (AC) in existing singlefamily homes
- Prescriptive pathway for AC installations with certain conditions



Alterations to Pool and/or Spa Heating

- Applies to multifamily and nonresidential pool or spa heater alterations
- Improves the efficiency of the pool heater
- Encourages the use of solar pool heating and heat pump pool heaters
