The proposed project consists of creating a climate change school with a curriculum that focuses on benefitting the environment, indigenous communities, and carbon sequestration capacity of the tribal rangelands. The proposed project will utilize workshops and consultations with indigenous stakeholders. The project is therefore limited to knowledge sharing and planning activities. The project does not involve any activities that may result in physical changes such as construction, installations, or alterations to land or facilities. This project is therefore exempt from CEQA pursuant to 14 Cal. Code Regs., tit. 14 section 15306 as information collection that will not result in any serious or major disturbance to an environmental resource.

Cal. Code Regs., tit. 14 section 15322 provides that projects that consist of the adoption, alteration, or termination of educational or training programs which involve no physical alteration in the area affected or which involve physical changes only in the interior of existing school training structures are exempt from CEQA. The proposed project consists of creating a climate change school that aims to benefit the environment, indigenous communities, and carbon sequestration capacity of tribal rangelands. Since the proposed project develops a curriculum and training methods, it is therefore exempt from CEQA under Section 15322.

This project is also covered by the Common Sense Exemption under 14 CCR 15061 (b) (3) that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.



The project will not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; does not involve any cumulative impacts of successive projects of the same type in the same place that might be considered significant; does not involve unusual circumstances that might have a significant effect on the environment; will not result in damage to scenic resources within a highway officially designated as a state scenic highway; the project site is not included on any list compiled pursuant to Government Code section 65962.5; and the project will not cause a substantial adverse change in the significance of a historical resource. Therefore, none of the exceptions to categorical exemptions listed in CEQA Guidelines section 15300.2 apply to this project and this project will not have a significant effect on the environment.
