Payment used for ground transportation, lodging, and per-diem for Patrick Saxton to attend the Getting to a Zero Carbon Buildings Sector workshop. The purpose of the event was a meeting of cities, states and building experts to examine the policies, financing, triggers, and consumer demand required to achieve the goal of a zero carbon building sector, and determine potential pathways to achieve this. As a world leader in this policy area, California's attendance played a key role in the workshop. California recently adopted the 2016 Building Code Update, which makes major steps toward zero net energy construction, a precursor to zero carbon buildings. Patrick Saxton had a key role in implementing this rulemaking and was determined to be the Commission's most appropriate representative and resource.
