# II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

# A. Purpose of Agreement

The purpose of this Agreement is to install and demonstrate an optimized compressed air system at the Recipient's raisin production facility. The optimized compressed air system will feature a unique energy efficient centrifugal compressor and heat recovery technology resulting in reduced greenhouse gas (GHG) emissions, energy consumption, and operating costs at a raisin production facility. Natural gas and electricity consumption will be measured before and after the system is installed in order to quantify and validate the GHG emissions reductions.

# B. Problem/ Solution Statement

#### **Problem**

California processes over 1 million tons of grapes per year and produces nearly 100 percent of raisins in the U.S.<sup>2</sup> Processing and packaging raisins is an energy intensive process which involves substantial use of compressed air. There is significant potential to improve the efficiency of current compressed air systems in food processing facilities by reducing runtime, recovering

waste heat, and operating at lower pressures. However, there is a lack of successful demonstrations of optimized compressed air systems in food processing facilities.

# **Solution**

The Recipient will demonstrate variable frequency drive (VFD) controlled centrifugal compressors, automation controls, and advanced air dryers at the Recipient's raisin production facility. The recipient will integrate the system into the food production operation, demonstrating the potential to significantly reduce electric and natural gas consumption in a food processing facilities in California. By implementing this technology at a large food processing facility, this project will demonstrate the potential for optimized compressed air systems to reduce GHG emissions, energy consumption, and operating costs at similar food processing facilities.

# C. Goals and Objectives of the Agreement

# **Agreement Goals**

The goals of this Agreement are to reduce GHG emissions and energy consumption by at least 10 percent at the raisin production facility by implementing an optimized compressed air system. These savings will also result in reduced operating costs at the facility.

# **Agreement Objectives**

The objectives of this Agreement are to:

- Measure the raisin production facility's electricity and natural gas consumption in order to establish a baseline for future comparisons.
- Specify and procure the necessary equipment and materials for the optimized compressed air system.
- Install and operate the optimized compressed air system at the raisin production facility.
- Measure and validate the electricity, natural gas, operating cost, and GHG emission reductions resulting from the optimized compressed air system.

### III. TASK 1 GENERAL PROJECT TASKS

# **PRODUCTS**

## **Subtask 1.1 Products**

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. Products that require a draft version are indicated by marking "(draft and final)" after the product name in the "Products" section of the task/subtask. If "(draft and final)" does not appear after the product name, only a final version of the product is required. With respect to due dates within this Scope of Work, "days" means working days.

# The Recipient shall:

- Submit all draft products to the CAM for review and comment in accordance with the Project Schedule (Part V). The CAM will provide written comments to the Recipient on the draft product within 15 days of receipt, unless otherwise specified in the task/subtask for which the product is required.
- Consider incorporating all CAM comments into the final product. If the Recipient disagrees
  with any comment, provide a written response explaining why the comment was not
  incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

# For products that require a final version only

 Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

• Submit all data and documents required as products in accordance with the following:

# <u>Instructions for Submitting Electronic Files and Developing Software:</u>

### Electronic File Format

Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission's software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. Deliver an electronic copy of the full text of any Agreement data and documents in a format specified by the CAM, such as memory stick or CD-ROM.

The following describes the accepted formats for electronic data and documents provided to the Energy Commission as products under this Agreement, and establishes the software versions that will be required to review and approve all software products:

Prior to the meeting, the CAM will provide an agenda to all potential meeting participants.
The meeting may take place in person or by electronic conferencing (e.g., WebEx), with
approval of the CAM.

The <u>administrative portion</u> of the meeting will include discussion of the following:

# Subtask 1.3 Critical Project Review (CPR) Meetings

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. CPR meetings generally take place at the Energy Commission, but they may take place at another location, or may be conducted via electronic conferencing (e.g., WebEx) as determined by the CAM.

- Prepare a *CPR Report* for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other *Task Products* that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).
- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

#### The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.
- Send the Recipient a CPR Agenda and a List of Expected CPR Participants in advance
  of the CPR meeting. If applicable, the agenda will include a discussion of match funding
  and permits.
- Conduct and make a record of each CPR meeting. Provide the Recipient with a *Schedule for Providing a Progress Determination* on continuation of the project.
- Determine whether to continue the project, and if so whether modifications are needed to
  the tasks, schedule, products, or budget for the remainder of the Agreement. If the CAM
  concludes that satisfactory progress is not being made, this conclusion will be referred to
  the Deputy Director of the Energy Research and Development Division.
- Provide the Recipient with a *Progress Determination* on continuation of the project, in accordance with the schedule. The Progress Determination may include a requirement that the Recipient revise one or more products.

# **Subtask 1.4 Final Meeting**

### The Recipient shall:

 Meet with Energy Commission staff to present project findings, conclusions, and recommendations. The final meeting must be completed during the closeout of this Agreement. This meeting will be attended by the Recipient and CAM, at a minimum. The (meeting may occur in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The technical and administrative aspects of Agreement closeout will be discussed at the meeting, which may be divided into two separate meetings at the CAM's discretion.

- The technical portion of the meeting will involve the presentation of findings, conclusions, and recommended next steps (if any) for the Agreement. The CAM will determine the appropriate meeting participants.
- The administrative portion of the meeting will involve a discussion with the CAM and the CAO of the following Agreement closeout items:

#### **Subtask 1.8 Permits**

Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

- Prepare a *Permit Status Letter* that documents the permits required to conduct this Agreement. If <u>no permits</u> are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
  - A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
  - o The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an *Updated List of Permits* (including the appropriate information on each permit) and an *Updated Schedule for Acquiring Permits*.
- Send the CAM a Copy of Each Approved Permit.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

#### TASK 2 SITE PREPARATION AND EQUIPMENT PROCUREMENT

The goal of this task is to prepare the site and procure the necessary equipment and materials for this project.

### The Recipient shall:

- Prepare the site including removal of existing equipment to be replaced. Equipment removal may occur in tandem with equipment installation to reduce facility downtime.
- Develop performance specification for new equipment to be purchased.
- Specify equipment, select a vendor, and issue purchase orders to the selected vendor.
- Secure all permits required to complete the project.
- Arrange for shipment, receipt, and inspection of the equipment at the facility.
- Procure the equipment for the optimized compressed air system such as:
  - Compressors with variable frequency drive motor controls, flow controller, and associated control system; and
  - Desiccant air dryers and waste heat recovery heat exchanger;
- Provide a Site Preparation and Equipment Procurement Memo that shall include, but not be limited to:
  - Summary of the steps to prepare the site(s);
  - Copy of the performance specifications for each equipment purchased by the grant;
  - Copies of all required permits needed for installation at each site;
  - Copies of the purchase orders showing final costs for the optimized compressed air system; and
  - Status of the planned installation including preliminary schedule for equipment delivery and installation.

# **TASK 3 EQUIPMENT INSTALLATION**

The goal of this task is to install and commission the necessary equipment for this project.

- Install the optimized compressed air system including compressors, flow controller, control
  system, desiccant air dryers, waste heat recovery heat exchanger, and associated
  mechanical and electrical connections.
- Verify the integrity and functionality of the installed equipment.
- Start-up and commission equipment with factory tech support and make adjustments as needed to meet stated performance specification.
- Adjust the system until it reaches its best efficiency point and lowest dynamic efficiency based on the facility load profile.

- Provide an *Equipment Installation Memo* that shall include, but not be limited to:
  - Summary of the equipment installation requirements;
  - Identification of barriers involved during installation and discuss the steps taken to overcome those barriers;
  - Discuss results of equipment start-up and commissioning with respect to whether the equipment as installed meets the stated performance specifications.
- Prepare a CPR Report #1 in accordance with subtask 1.3.
- Participate in a CPR Meeting.

#### TASK 4 MEASUREMENT AND VERIFICATION

The goal of this task is to report the benefits resulting from this project by performing measurement and verification (M&V) of GHG and energy consumption reduction.

- Enter into agreement with M&V subcontractor per Task 1.9 (if using outside vendor)
- Coordinate site visits with the M&V subcontractor at the demonstration site
- Develop M&V protocol for *pre-installation* measurement (and calculation):
  - Electric, natural gas and/or other fossil fuel consumption and GHG emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation) of the equipment/process/system(s)/sub-system(s) that are to be upgraded and/or replaced and/or modified.
  - If necessary, ensure installation of sub-metering equipment and data loggers for pre/post data analysis.
- Prepare and provide a detailed M&V Plan to include but not be limited to:
  - A description of the monitoring equipment and instrumentation which will be used.
  - A description of the key input parameters and output metrics which will be measured.

- Perform three months (or shorter period as approved in writing by the CAM) of preinstallation measurements (and calculations) based on the M&V protocol for pre-install
- Prepare and provide a Pre-Installation M&V Findings Report for each demonstration site
  that includes M&V protocol, pre-installation measurements (and calculations), analysis,
  and results performed in this task.
- Develop M&V protocol for post-installation measurements (and calculations) of:
  - Electric, natural gas and/or other fossil fuel consumption and GHG emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation) of the equipment/process/system(s)/sub-system(s) that will be upgraded and/or replaced and/or modified
- Perform 12 months (or shorter period as approved in writing by the CAM) of post-installation measurements based on M&V protocol for post-installation.

- Provide a summary of post-installation M&V progress in Progress Report(s) (see subtask
   1.5) which shall include but not be limited to:
  - A narrative on operational highlights from the reporting period, including any stoppages in operation and why; and
  - A summary of M&V findings from the reporting period.
- Analyze post-install electrical, natural gas and/or other fossil fuel consumption and GHG emissions.
- Prepare and provide a Post-Installation M&V Findings Report that includes M&V protocol, pre and post install measurements (and calculations), analysis, and results performed in this task. Results should at a minimum report on the reduction of electricity, natural gas and/or other fossil fuel usage and reductions of GHG emissions that directly result from this project.
  - Provide all key assumptions used to estimate and determine energy and GHG reductions (and additions, if applicable).
  - Provide all key assumptions used to estimate projected benefits, including targeted market sector (e.g., population and geographic location), projected market penetration, baseline and projected energy use and cost, operating conditions, and emission reduction calculations.
- Prepare a CPR Report #2 in accordance with subtask 1.3.
- Participate in a CPR Meeting.
