SUMMARY PROJECT DESCRIPTION: Expand the existing Pleasant Grove Wastewater Treatment Plant (Expansion Project) treatment capacity from 9.5 million gallons per day, to its original 12 million gallons per day design capacity; and, construct related but separate energy recovery facilities (Energy Recovery Project). The Addendum to the original Expansion Project and Energy Recovery Project Initial Study/Mitigated Negative Declaration (February 2017) (Original IS/MND) was prepared to address the following project revisions (Revised Project): 1) relocation of the proposed Pacific Gas & Electric (PG&E) natural gas pipeline, 2) relocation of proposed construction staging areas, 3) changes in the phasing of solid waste trucks that would be available for fueling with renewable compressed natural gas, and 4) delays in the anticipated construction start date.

DETERMINATIONS FOR THE ADDENDUM TO THE ORIGINAL IS/MND

This notice is to advise interested parties that the Roseville City Council (Lead Agency) has approved and made the following determinations regarding the above-described project:

- The City concluded, based on substantial evidence, that the Revised Project will not have any new or more severe effects on the environment compared to those disclosed in the original IS/MND. For this reason, no subsequent or Supplemental IS/MND or EIR was required.
- The February 2017 Original IS/MND was previously adopted by the City of Roseville pursuant to the provisions of CEQA (SCH#2016122040). The Addendum to the Original IS/MND (June 2018) was prepared, considered and adopted by the Roseville City Council prior to approving the Revised Project as described in the Addendum.
- As approved, the project will not have a significant effect on the environment.
- A revised Mitigation Monitoring and Reporting Program was approved and the identified mitigation measures were made "required conditions of approval" for the project.
- A Statement of Overriding Considerations was not adopted for this project.
- Findings were previously made pursuant to the provisions of CEQA.

ADOPTING THE ADDENDUM TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PLUS INITIAL STUDY/MITIGATED NEGATIVE DECLARATION, APPROVING THE REVISED MITIGATION MONITORING AND REPORTING PLAN, AND APPROVING THE PLEASANT GROVE WASTEWATER TREATMENT PLANT EXPANSION & ENERGY RECOVERY PROJECTS AS DESCRIBED IN THE ADDENDUM

WHEREAS, the City of Roseville, pursuant to the City of Roseville Procedures for the Preparation, Processing and Review of Environmental Documents ("the Procedures"), has submitted to the City Council, acting as Approving Authority pursuant to said Procedures, an Addendum to the California Environmental Quality Act (CEQA)-Plus Initial Study/Mitigated Negative Declaration for the Pleasant Grove Wastewater Treatment Plant Expansion & Energy Recovery Projects located in Roseville, California ("the Project"); and

WHEREAS, the Council has considered the recommendation of staff and the Addendum to the CEQA-Plus Initial Study/Mitigated Negative Declaration, together with all public comments received during the public review process; and

WHEREAS, the City Clerk's Department is the custodian of record of the record of proceedings and such documents are on file with the City Clerk's Department; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Roseville that it finds on the basis of the Addendum to the CEQA-Plus Initial Study/Mitigated Negative Declaration, and the whole record, including public comments and other documents, that if the Pleasant Grove Wastewater Treatment Plant Expansion & Energy Recovery Projects is conditioned with mitigation measures as proposed, there is no substantial evidence that the Project will have a significant effect on the environment; the Addendum to the CEQA-Plus Initial Study/Mitigated Negative Declaration reflects the independent judgment and analysis of the City of Roseville, and the Addendum to the CEQA-Plus Initial Study/Mitigated Negative Declaration for the Project is hereby adopted.

BE IT FURTHER RESOLVED, the Mitigation Monitoring and Reporting Plan for the Pleasant Grove Wastewater Treatment Plant Expansion & Energy Recovery Projects is hereby approved.

BE IT FURTHER RESOLVED that the Pleasant Grove Wastewater Treatment Plant Expansion & Energy Recovery Projects as described in the Addendum is hereby approved and staff is directed to move forward with the proposed project.
