EXHIBIT A Scope of Work The Clara Fund

PURPOSE

The purpose of this Agreement is to formalize the California Energy Commission's (CEC) support for the Electric Innovation Initiative's (EII) annual events and activities through a co-sponsorship with The Clara Fund. The Electric Innovation Initiative is a national effort to accelerate the equitable transition to an all-electric economy—cutting costs, improving public health, and strengthening American industry and is designed to connect cutting-edge innovation with state and local decision-makers.

The EII program is ramping up year-round activities and kicking off its inaugural annual Electric Innovation Awards during Climate Week NYC 2025, where Energy is a key theme and is integral to the other nine key themes. This event is designed to highlight groundbreaking electric solutions, help shape public understanding, and catalyze policy action.

CEC's engagement with and co-sponsorship of the EII's annual events and activities will facilitate California's clean energy innovators in sharing their work nationally, and enable state and local policymakers to learn more about the impactful benefits of electrification.

Core annual activities for the EII include:

- Electric Innovation Awards: Host an annual national awards program to highlight groundbreaking solutions, create a high-profile moment of recognition, and catalyze policy action.
- Innovation Site Visits: Organize three to four in-state visits where
 policymakers engage directly with awardee projects, building hands on
 understanding of electrification benefits.
- Policymaker Cohort Development: Establish the inaugural bipartisan Policymaker Cohort on Electrification, creating peer networks of state and local champions.
- Follow On Convenings: Facilitate targeted workshops with awardees, policymakers, and Non-Governmental Organizations to map innovation models to policy opportunities.
- Amplification: Produce and distribute storytelling assets tailored to policymakers and policy networks, ensuring awardee innovations remain visible in state level debates.
- Policy Momentum: Track adoption of awardee inspired commitments, pilots, or legislative and regulatory proposals in at least three states by the end of 2026.
