Scope of Work

PURPOSE

The purpose of this Agreement is to formalize the California Energy Commission's co-sponsorship of the Electric Power Research Institute's (EPRI) 2019 Pathways to Decarbonization in the Western U.S. Symposium, which will take place on July 11 through July 12 in Berkeley, California. The Symposium will bring together western state government and regulatory bodies with utilities, researchers, academia, manufacturers, vendors, and industry stakeholders to listen, learn, and network with a focus on the decarbonization and electrification of buildings and transportation. The event will include joint plenary sessions on cross-sector infrastructure planning, as well as breakout sessions focused specially on challenges and opportunities in buildings and transportation.

Additionally, the symposium will include a technology expo, showcasing innovations in decarbonization technologies. The symposium will provide an opportunity for stakeholders to coordinate planning efforts, share updates, and have collaborative discussions on the State's goals of 100 percent clean electricity and decarbonization across all sectors by 2045. High attendance levels is anticipated from Energy Commission and other governmental state and local agencies staff. Registration will be extended at no cost in lieu of government attendance and participation to encourage engagement with a wide range of stakeholders on key focus areas, including R&D, energy system planning, and climate and energy policy.
