# II. PURPOSE OF AGREEMENT, PROBLEM/SOLUTION STATEMENT, AND GOALS AND OBJECTIVES

# A. Purpose of Agreement

The purpose of this Agreement is to install an advanced multi-effect evaporator system with mechanical vapor recompression (MVR) technology, and retrofit the existing evaporator electric circulation pumps with steam turbines. The installation of the evaporator and steam turbines will significantly reduce the overall greenhouse gas (GHG) emissions at the facility. Natural gas consumption will be measured before and after the system is installed in order to quantify and validate the GHG emission reductions.

## B. Problem/ Solution Statement

### **Problem**

California processes over 10 million tons of tomatoes per year and produces approximately 95% of processed tomato products in the U.S. <sup>2</sup> Common tomato products include peeled tomatoes, diced tomatoes, tomato sauce, and tomato paste. Processing tomatoes into tomato products is an

energy intensive process requiring large amounts of heat, typically provided by burning natural gas. Currently the Recipient uses evaporators to remove water from tomatoes during processing to make various concentrated tomato products. The current system is very energy intensive and results in a large amount of GHG emissions. A major barrier to augmenting the current equipment is the significant cost and limited availability of a locally proven technology solution.

# **Solution**

This grant would allow the Recipient to augment the existing evaporator system with MVR technology and steam turbines, and meet its internal financial requirement.

# C. Goals and Objectives of the Agreement

# **Agreement Goals**

The goals of this Agreement are to:

- Reduce overall operating costs
- Accelerate the adoption of the MVR technology in California
- Maintain current production levels
- Maintain or increase current product quality levels
- Benefit the low-income community through reduced GHG levels
- Benefit California business by purchasing the equipment from California based vendor(s).

# Agreement Objectives

The objectives of this Agreement are to:

- Measure the tomato processing facility's current natural gas consumption in order to establish a baseline for future comparisons.
- Install and operate the pre-evaporator system at the tomato processing facility.
- Measure and validate the natural gas and GHG emissions reductions resulting from incorporating the MVR technology and steam turbines.
- Introduce a new energy efficiency technology to California food production facilities.

#### **III. TASK 1 GENERAL PROJECT TASKS**

## **PRODUCTS**

#### **Subtask 1.1 Products**

The goal of this subtask is to establish the requirements for submitting project products (e.g., reports, summaries, plans, and presentation materials). Unless otherwise specified by the Commission Agreement Manager (CAM), the Recipient must deliver products as required below by the dates listed in the **Project Schedule (Part V)**. - Consider incorporating all CAM comments into the final product. If the Recipient disagrees
  with any comment, provide a written response explaining why the comment was not
  incorporated into the final product.
- Submit the revised product and responses to comments within 10 days of notice by the CAM, unless the CAM specifies a longer time period, or approves a request for additional time.

# For products that require a final version only

• Submit the product to the CAM for acceptance. The CAM may request minor revisions or explanations prior to acceptance.

# For all products

Submit all data and documents required as products in accordance with the following:

# Instructions for Submitting Electronic Files and Developing Software:

#### Electronic File Format

Submit all data and documents required as products under this Agreement in an electronic file format that is fully editable and compatible with the Energy Commission's software and Microsoft (MS)-operating computing platforms, or with any other format approved by the CAM. Deliver an electronic copy of the full text of any Agreement data and documents in a format specified by the CAM, such as memory stick or CD-ROM.

The meeting may take place in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

# **Subtask 1.3 Critical Project Review (CPR) Meetings**

The goal of this subtask is to determine if the project should continue to receive Energy Commission funding, and if so whether any modifications must be made to the tasks, products, schedule, or budget. CPR meetings provide the opportunity for frank discussions between the Energy Commission and the Recipient. As determined by the CAM, discussions may include project status, challenges, successes, final report preparation, and progress on technical transfer and production readiness activities (if applicable). Participants will include the CAM and the Recipient, and may include the CAO and any other individuals selected by the CAM to provide support to the Energy Commission.

CPR meetings generally take place at key, predetermined points in the Agreement, as determined by the CAM and as shown in the Task List on page 1 of this Exhibit. However, the CAM may schedule additional CPR meetings as necessary. The budget will be reallocated to cover the additional costs borne by the Recipient, but the overall Agreement amount will not increase. - Prepare a CPR Report for each CPR meeting that: (1) discusses the progress of the Agreement toward achieving its goals and objectives; and (2) includes recommendations and conclusions regarding continued work on the project.
- Submit the CPR Report along with any other Task Products that correspond to the technical task for which the CPR meeting is required (i.e., if a CPR meeting is required for Task 2, submit the Task 2 products along with the CPR Report).

- Attend the CPR meeting.
- Present the CPR Report and any other required information at each CPR meeting.

#### The CAM shall:

- Determine the location, date, and time of each CPR meeting with the Recipient's input.

This meeting will be attended by the Recipient and CAM, at a minimum. The (meeting may occur in person or by electronic conferencing (e.g., WebEx), with approval of the CAM.

The technical and administrative aspects of Agreement closeout will be discussed at the meeting, which may be divided into two separate meetings at the CAM's discretion.

 The technical portion of the meeting will involve the presentation of findings, conclusions, and recommended next steps (if any) for the Agreement. The CAM will determine the appropriate meeting participants.

- The administrative portion of the meeting will involve a discussion with the CAM and the CAO of the following Agreement closeout items:

#### **Subtask 1.7 Match Funds**

The goal of this subtask is to ensure that the Recipient obtains any match funds planned for this Agreement and applies them to the Agreement during the Agreement term.

While the costs to obtain and document match funds are not reimbursable under this Agreement, the Recipient may spend match funds for this task. The Recipient may only spend match funds during the Agreement term, either concurrently or prior to the use of Energy Commission funds. #### **Subtask 1.8 Permits**

The goal of this subtask is to obtain all permits required for work completed under this Agreement in advance of the date they are needed to keep the Agreement schedule on track. Permit costs and the expenses associated with obtaining permits are not reimbursable under this Agreement, with the exception of costs incurred by University of California recipients. Permits must be identified and obtained before the Recipient may incur any costs related to the use of the permit(s) for which the Recipient will request reimbursement.

### The Recipient shall:

- Prepare a Permit Status Letter that documents the permits required to conduct this Agreement. If no permits are required at the start of this Agreement, then state this in the letter. If permits will be required during the course of the Agreement, provide in the letter:
  - o A list of the permits that identifies: (1) the type of permit; and (2) the name, address, and telephone number of the permitting jurisdictions or lead agencies.
  - The schedule the Recipient will follow in applying for and obtaining the permits.

The list of permits and the schedule for obtaining them will be discussed at the Kick-off meeting (subtask 1.2), and a timetable for submitting the updated list, schedule, and copies of the permits will be developed. The impact on the project if the permits are not obtained in a timely fashion or are denied will also be discussed. If applicable, permits will be included as a line item in progress reports and will be a topic at CPR meetings.

- If during the course of the Agreement additional permits become necessary, then provide the CAM with an Updated List of Permits (including the appropriate information on each permit) and an Updated Schedule for Acquiring Permits.
- Send the CAM a Copy of Each Approved Permit.
- If during the course of the Agreement permits are not obtained on time or are denied, notify the CAM within 5 days. Either of these events may trigger a CPR meeting.

- Develop equipment performance specifications.
- Solicit bids for site preparation and equipment installation activities.
- Complete core drilling and prepare the concrete for equipment installation.
- Issue purchase orders for equipment.
- Arrange for shipping of the evaporator system to the Recipient's facility.
- Provide a Site Preparation and Equipment Procurement Memo that shall include, but not be limited to:
  - Summary of the steps taken to prepare the site;
  - Copy of the performance specifications for each piece of equipment purchased for the project;
  - Summary of the bids received and from whom;
  - o Copies of all required permits needed for installation; and
  - Status of the planned installation, including preliminary schedule for equipment delivery and installation.

#### **TASK 3: EQUIPMENT INSTALLATION**

The goal of this task is to install the necessary equipment for this project. The Recipient will install an MVR evaporator and two steam turbines at the Woodland facility.

- Select and oversee contractor for installation of the system.
- Complete hydrostatic testing.
- Complete programming.
- Test clean-in-place procedure.
- Start-up and commission equipment and make adjustments as needed to meet stated performance specification.
- Provide an Equipment Installation Memo that shall include, but not be limited to:
  - o Summary of the equipment installation requirements for the demonstration site;
  - Identification and discussion of barriers involved during installation and the steps taken to overcome those barriers; and
  - Discussion of results of equipment start-up and commissioning including whether the installed equipment meets the stated performance specifications.
- Prepare CPR Report #1 and participate in a CPR meeting per subtask 1.3.

## **TASK 4: MEASUREMENT AND VERIFICATION**

The goal of this task is to report the benefits resulting from this project.

- Enter into agreement with Measurement and Verification (M&V) subcontractor per Task 1.9.
- Coordinate site visits with the M&V subcontractor at the demonstration site.
- Develop M&V protocol for pre-installation measurement (and calculations) following Section II.B.2 of the grant solicitation manual <sup>3</sup>:
  - Electric, natural gas and/or other fossil fuel consumption and greenhouse gas emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation manual) of the equipment/process/system(s)/sub-system(s) that are to be upgraded and/or replaced and/or modified; and
  - If necessary, ensure installation of sub-metering equipment and data loggers for pre/post data analysis.
- Prepare and provide a detailed Measurement and Verification Plan to include but not be limited to:
  - A description of the monitoring equipment and instrumentation which will be used;
  - o A description of the key input parameters and output metrics which will be measured;
  - A description of the M&V protocol and analysis methods to be employed; and
  - A description of the independent, third-party measurement and verification services to be employed.
- Perform three months (or shorter period as approved in writing by the CAM) of preinstallation measurements (and calculations) based on the M&V protocol for pre-install.
- Prepare and provide a *Pre-Installation Measurement and Verification Findings Report* for each demonstration site that includes M&V protocol, pre-install measurements (and calculations), analysis, and results performed in this task.
- Develop M&V protocol for post-installation measurements (and calculations) of:
  - Electric, natural gas and/or other fossil fuel consumption and greenhouse gas emissions (use appropriate emissions factor from Attachment 8 of the grant solicitation manual) of the equipment/process/system(s)/sub-system(s) that will be upgraded and/or replaced and/or modified.
- Perform 12 months or two seasons, for seasonal facilities, (or shorter period as approved in writing by the CAM) of post-installation measurements based on M&V protocol for postinstallation.
- Provide a summary of post-installation M&V progress in Progress Report(s) (see subtask
   1.5) which shall include, but not be limited to:
  - A narrative on operational highlights from the reporting period, including any stoppages in operation and why; and
  - A summary of M&V findings from the reporting period.

- Analyze post-installation electrical, natural gas and/or other fossil fuel consumption and greenhouse gas emissions.
- Prepare and provide a Post-Installation Measurement and Verification Findings Report for each demonstration site, to include M&V protocol, pre and post installation measurements (and calculations), analysis, and results performed in this task. Results should at a minimum report on the reduction of electricity, natural gas and/or other fossil fuel usage, and reductions of greenhouse gas emissions that directly result from this project to include but not be limited to:
  - Provide all key assumptions used to estimate and determine energy and greenhouse gas reductions (and additions, if applicable); and
  - Provide all key assumptions used to estimate projected benefits, including targeted market sector (e.g., population and geographic location), projected market penetration, baseline and projected energy use and cost, operating conditions, emission reduction calculations, and benefits to disadvantaged communities, if applicable.
