### **SCOPE OF WORK**

#### **PURPOSE**

The purpose of this agreement is for the California Energy Commission (CEC) to join as a Public Sponsor Member, for one year, of the National Wind Technology Consortium, Inc. doing business as National Offshore Wind Research and Development Consortium (NOWRDC or the Consortium).

NOWRDC is a nationally-focused, not-for-profit organization that supports and promotes research and development (R&D) activities that address technological and supply chain barriers to offshore wind deployment and helps lower development risk to investors. NOWRDC was established in 2018 when the U.S. Department of Energy selected the New York State Energy Research and Development Authority (NYSERDA), in partnership with the Renewables Consulting Group (RCG) and the Carbon Trust (CT), to lead the formation of a nationwide R&D consortium for the offshore wind industry. The intent is to facilitate and enhance the development and implementation of offshore wind power technology through scientific research in the public interest for the public purpose of increasing the performance and capability of the electric power supply and delivery system. NOWRDC manages industry-focused research and innovation with state and federal government collaboration to bring down the levelized cost of energy of offshore wind in the United States. Like the CEC's Electric Program Investment Charge (EPIC), NOWRDC supports renewable energy innovations by conducting solicitations and managing research projects that could reduce the costs associated with offshore wind and provide economic and societal benefits.

Membership with NOWRDC will help accelerate the deployment of offshore wind in California by adding to the pool of critical resources needed to overcome various challenges. Benefits gained from the membership include access to NOWRDC's network of experts from the offshore wind industry, state and federal government, and access to results and lessons from offshore wind deployment projects in other states, that critically inform, enrich and facilitate offshore wind energy research, development and deployment under EPIC through activities such as:

- CEC participation on the advisory boards for NOWRDC projects of interest.
- NOWRDC members serving on technical advisory committees for CEC EPIC grants.
- Leverage the national, potentially international, influence of the organization.
- Involvement in NOWRDC committees, such as Research and Development Advisory Group, Manufacturing Supply Chain Services Council, and State Action Network, to help shape research objectives and solicitations.
- Accessing networks and resources connecting technology innovators, investors, and industry.

#### **PUBLIC SPONSOR MEMBERSHIP OF CEC**

As a Public Sponsor Member, the CEC will have the ability to nominate and vote for those serving on the Board of Directors, but will not nominate a Director from among its employees or to vote in Board elections.

Public Sponsor Members can nominate individuals (including their employees) to serve as “Adjunct” members of the Consortium’s Research and Development Committee, which sets the Consortium’s research priorities and makes all decisions with respect to project awards and other matters. Adjunct Committee Members have the right to attend all meetings and participate in discussions and make recommendations, but do not vote. The Consortium has looked to technical experts employed by its Members to serve on the Scoring Committees that assist in reviewing project proposals received in response to its solicitations.

In addition, Public Sponsor Member representatives are invited to attend all other Consortium meetings (i.e. Board meetings, as non-voting invitees, other than “executive session” meetings, which are uncommon), the Project Advisory Boards (PABs), and the State Action Network.

- PABs, which exist for each contracted project, provide an opportunity for all Members to engage more deeply in a specific project activity. Members are encouraged to have a representative on PABs for projects they are interested in. PABs meet quarterly to review and provide feedback on project accomplishments and plans.
- The State Action Network, open to only state Members, meets quarterly to discuss various issues impacting states in a small forum. The State Action Network is not a governing body but a "place" where common issues and potential collaboration is discussed.

#### **NOWRDC MISSION AND DESIRED IMPACTS**

- Facilitate a nationally-focused, not-for-profit organization collaborating with industry on prioritized R&D activities to reduce levelized cost of energy (LCOE) of offshore wind in the U.S. and maximize other economic and social benefits.
  - Innovations directly responsive to the technical and supply chain barriers faced by offshore wind project developers in the U.S.
  - Build strong networks connecting technology innovators, investors, and industry.
  - Increase U.S. content and job opportunities.

#### **NOWRDC RESEARCH PILLARS**

- Pillar 1: Offshore Wind Farm Technology Advancement. Technology advancements targeted at the major cost drivers of offshore wind and domestic physical siting challenges in wind turbine and wind farm technology.
- Pillar 2: Offshore Wind Power Resource and Physical Site Characterization. Improvements in offshore wind site characterization and site characterization technology that can drive significant cost reduction in U.S. offshore wind projects.
- Pillar 3: Installation, Operations and Maintenance (O&M), and Supply Chain. Technology improvements in wind farm installation, O&M, and supply chain issues related to the U.S. market, socioeconomic, and geophysical constraints.

#### **PRIORITY TOPICS BENEFITTING CALIFORNIA**

NOWRDC maintains an industry-focused offshore wind R&D agenda to help accelerate early U.S. offshore wind project development, LCOE reduction, and geographic industry expansion. NOWRDC priority topics that could benefit the offshore wind industry in California include:

- Industrialization of the Floating Supply Chain
- Workforce Development
- Floating Substructures
- Characterization of Atmospheric and Ocean Conditions at U.S. Wind Energy Areas
- Floating Wind Operations and Maintenance

#### **NOWRDC MEMBER CATEGORIES AND COMMITTEES**

- Developer Members. Organization developing or operating offshore wind power generation plants, with a significant strategic commitment to further develop, operate, and own offshore wind power generation plants in the United States.

otherwise supporting the production, transmission, distribution, sale, and utilization of electric power generated from offshore wind for the public benefit.

- Independent Members. Any public or private entity or individual that can provide scientific, industry, or other expertise or perspective significantly benefitting the Corporation's purposes.
- Director Members. Individuals serving as members of the Corporation's Board of Directors.

#### **Committees:**

- Board of Directors. Consist of member representatives (one seat per member, one vote, no proxies permitted), provides overall leadership and governance of the Consortium.
- Executive Committee. Elected members, with exception of NYSDERA and NOWRDC Executive Director who are ex-officio, exercise all the powers of the Board and act in its stead between meetings of the Board of Directors.
- Research and Development Committee. A Board-level committee, makes all determinations regarding NOWRDC's research and development priorities, solicitations, and project awards or completions.
