On December 15, 2017 the Los Angeles Department of Water and Power (LADWP) filed a Petition for Corrections to Transcript of CEC Business Meeting Held on October 11, 2017 (Petition). The Petition included a total of 31 requests for corrections to the Energy Commission October 11, 2017 business meeting transcript.

Energy Commission regulation section 1105 allows any person to petition the Energy Commission to correct a transcript of his or her own statements during an Energy Commission business meeting. (Cal. Code Regs., tit. 20, § 1105(d).) In turn, the Energy Commission is to consider such a petition at a business meeting, on the consent calendar if warranted by the facts presented. (*Id.*; Cal. Code Regs., title 20, § 1104(d).)

As discussed below, the facts warrant presentation and consideration of LADWP's Petition as a consent item, as the Energy Commission's Chief Counsel's Office (CCO) and LADWP's legal counsel have agreed on the scope of requested corrections that merit correction.

Background

At the October 11, 2017, business meeting the Commissioners heard and issued a decision in the matter entitled "Los Angeles Department of Water and Power Renewables Portfolio Standard (RPS) Appeal." Energy Commission staff and LADWP representatives appeared before the Commissioners and discussion of the matter was transcribed. Pursuant to Energy Commission regulation section 1105, LADWP legal counsel Todd J. Guerrero and Jean-Claude Bertet petitioned for corrections to the transcription of certain of their oral statements at the October 11, 2017 business meeting.

The Energy Commission Chief Counsel's Office (CCO) reviewed the Petition and compared the requested corrections in the Petition to the audio recording of the October 11, 2017 business meeting. Based on this review and practical considerations, CCO determined that all but eight of the 31 requested corrections were appropriate and consistent with the audio recording. CCO apprised Mr. Guerrero and Mr. Bertet of this determination and provided them with access to the audio recording. Mr. Guerrero and Mr. Bertet agreed with CCO. **Attachment 1** to this memo comprises copies of the

email communications supporting the assertions in this paragraph. **Attachment 2 to this memo** identifies the requests that are not supported by the audio recording.

We note that the attached email exchange also reflects agreement that the October 11, 2017 business meeting transcript at 35:21 requires a correction. The proposed corrected phrase for the transcript at 35:21 should read as follows: ". . . *in the regulatory scheme.*"

Recommendation

Based on the discussion above and attachments hereto, CCO recommends that the Energy Commission:

- Grant all requests for corrections from the Petition except the eight (8) requests appearing in attachment 2 hereto.
- Deny the Petition as to the eight (8) requests appearing in attachment 2 hereto.
- Grant a correction to the October 11, 2017 business meeting transcript at 35:21, changing "steam" to "scheme" such that the corrected phrase reads as follows: ". . . *in the regulatory scheme.*"

Good Afternoon,

This email is in reference to LADWP's Petition for Corrections to Transcript of CEC Business Meeting Held on October 11, 2017. Pursuant to Commission regulations section 1105, the Petition will be presented for consideration at the January 17, 2018 Commission business meeting.

The Chief Counsel's Office compared the audio recording of the October 11, 2017 business meeting with the transcript of the same and considered punctuation requests that would not be captured in an audio recording. Based on the audio recording and the reasonableness of the punctuation requests, we have no objection to all but eight of the requested corrections. The eight requests shown below are not supported by the audio recording.

Request 1: Transcript at 14:24 – the word “minutes” should be changed to “minute.” The proposed corrected phrase of the sentence contained on the transcript 14:24 should read as follows: *minute of presentation?*

Request 3: Transcript at 33:25 – the last word on line 25 “buzzwords” should be replaced with the word “buzzword.” The proposed corrected phrase contained on the transcript at 33:25 should read as follows: *renewable energy resource – there's the buzzword,*

Request 8: Transcript at 35:9 – the word “it” should be deleted. The proposed corrected phrase contained on the transcript at 35:9 should read as follows: . . . *intended to do otherwise.*

Request 9: Transcript at 35:21 – the word “steam” should be replaced with the word “system.” The proposed corrected phrase contained on the transcript at 35:21 should read as follows: . . . *in the regulatory system.* The audio recording indicates Mr. Guerrero stated “scheme” not “system.” If any change is made, the word “steam” should be changed to “scheme.”

Request 18: Transcript at 38:19 – a comma should be inserted after the word “stated.” The proposed corrected phrase contained on the transcript 38:19 should read as follows: . . . *history as mere “generalized statements.”*

Request 21: Transcript at 39:6 – the word “the” should be inserted before the word “vague” and quotation marks should be inserted around the phrase “vague reference to rules in place.” The proposed corrected phrase contained on the transcript 39:6 should read as follows: *But finds the “vague reference to rules in place,”*

Request 29: Transcript at 69:18 – the word “Commission” should be added to the end of the sentence in place of “- .” The proposed corrected phrase contained on the transcript at 69:18 should read as follows: . . . *that known to the Commission.*

Request 30: Transcript at 61:15 – the word “If” should be added to the beginning of the sentence that begins on line 15, page 61. The proposed corrected phrase of the sentence contained on the transcript 61:15 should read as follows: *If the Legislature wanted to specify each and every contract*

Finally, while we do not object to Request 6 (Transcript at 34:21-22 – quotations should be inserted around the words “eligible renewable energy resource.”), we do note that the audio recording captures Mr. Guerrero saying “eligible renewable resource.”

We invite you to review the audio recording, access to which will be provided to you in a separate email from Energy Commission Secretary Cody Goldthrite. If you concur with our assessment of the audio recording and your above-listed requests, consideration of the Petition can occur at the January 17 business meeting by way of the consent calendar. Items on the consent calendar are voted on en masse without discussion, in accordance with Commission regulation 1104. The consent calendar is used for items where there is no discussion or controversy. The Energy Commission business meeting agenda will be posted tomorrow, so your response is requested by 1:30 pm tomorrow Friday, January 5, so that if there is agreement as to the transcript changes there is time to place this item on the consent calendar.
