### Joint Energy, Climate, and Sustainable Communities Planning Project

- **Goals**: Advance the sustainability planning efforts of multiple agencies at three tribes and unify those efforts. Inter-tribal collaboration will include assessing mutual needs, goals, and opportunities that are shared among the three tribes; identifying priorities for inter-tribal planning and development; and conducting advanced collaborative planning on mutual strategies selected by the three tribes' leaders.

### Pala, Rincon, and San Pasqual Reservations

- North-Central San Diego County
- Within a four-mile radius
- Various overlapping plans:
  - FEMA HMP and EMP
  - Climate adaptation plan
  - Strategic Energy Plan
  - Tribal Environmental Plan
- Mutual needs and priorities can be shared



## **Karuk Tribe**

### <u>Áhish Áah (turn on the light): An Initiative for Climate and Energy Solutions</u>

- **Goals**: The project objectives are designed to strengthen the Karuk Tribe's Department of Natural Resource, the community's capacity, its energy independence, and the ecosystem resilience of the Karuk Aboriginal Territory.
- **Partners**: Humboldt State University, University of California Berkeley, Stanford University, and community collaborations with the Western Klamath Restoration Project partnership.







## **Scotts Valley Band of Pomo Indians**

### **Bioenergy Feasibility Studies in Indian Country**

- **Goals**: To support energy planning and feasibility studies for bioenergy generation facilities that may be installed and operated on Tribal Lands. The outcome is to deliver a standardized tool for matrix review and criteria scoring that can be applied to qualify and prioritize any potential bioenergy project on any Tribal property or facility.
- Partners: Scotts Valley Energy Company, consultants


