POUs may use this attestation to demonstrate that all underlying contract(s) between the JPA or third-party supplier and RPS-certified facilities supplying the electricity products to the POU meet the applicable portions of the Long-Term Procurement Requirements (LTR) specified in *The Enforcement Procedures for the Renewables Portfolio Standard for local Publicly Owned Electric Utilities* (RPS POU Regulations), section 3204 (d)(2)(A)-(C).

Consistent with Section 3207 (d)(2)(F)1.-2. of the RPS POU Regulations, California Energy Commission (CEC) staff will use this attestation to evaluate the LTR eligibility of the underlying contract(s) associated with a POU's long-term contract(s) or resale agreement(s) with a JPA or third-party supplier. A POU may only complete this attestation if it possesses records to support the accuracy of the information to which it attests and agrees to make such records available to the CEC upon request.

One attestation submission is required for each POU and long-term contract agreement with a JPA or third-party supplier, even if multiple POUs are a party to a single contract with a JPA or third-party supplier.

POUs must upload the electronic file of the completed attestation(s) using the upload feature in the "POU Contracts" reporting page within the RPS Online System. The link to the RPS Online System is provided below:
