# Updates for 2024 RPS Annual Reporting

- POU with qualifying procurement of coal-fired generation<sup>1</sup> in RPS Compliance Period 4

Qualifying procurement of coal-fired generation means coal-fired generation that is procured from “unavoidable long-term contracts and ownership agreements.”

Unavoidable long-term contracts and ownership agreements means commitments for electricity from a coal-fired powerplant, located outside the state, originally entered into by a local publicly owned electric utility before June 1, 2010, that is not subsequently modified to result in an extension of the duration of the agreement or result in an increase in total quantities of energy delivered during any compliance period.

1. Refer to PUC 399.30 (l)(1) – 399.30 (l)(3) / 20 CCR section 3204 (b)(10)



# Annual Report Scope & Schedule

---

- Reports are due no later than July 1, 2025, for reporting year 2024

# Annual Reporting – All LSEs

**All load-serving entities** (both retail sellers and publicly owned electric utilities) shall report REC retirements for previous reporting year to the CEC annually on July 1. (RPS Eligibility Guidebook, 9th edition (Revised), Ch. 7 / 20 CCR 3207 (c))

**A complete annual report includes the following components:**

1. WREGIS State/Provincial/Voluntary Compliance Report (WREGIS Report)<sup>1</sup>
  2. Attestation for WREGIS Report(s)<sup>2</sup>
  3. WREGIS Adjustment(s),<sup>3</sup> if applicable
1.   2. LSE must submit attestation in RPS Online at <https://rps.energy.ca.gov/Login.aspx> after their WREGIS Report(s) are uploaded.
  3. WREGIS Adjustment requests shall be requested in RPS Online at <https://rps.energy.ca.gov/Login.aspx>.





# Annual Reporting – POUs only

## Additional Reporting Requirements for POU\*s

1. Annual Summary Report in RPS Online
2. New, amended, modified POU contracts and ownership agreements executed in prior year (in RPS Online)
3. New, amended, modified POU contracts or resale agreements w/ JPA or third-party supplier containing ST + LT underlying resources\*\*
4. Newly executed POU prepayment transactions for PCC 0 or PCC 1 contracts\*\*\*

\* All requirements may not apply to all POU\*s

# Annual Reporting cont. – POUs only

## Additional Reporting Requirements for POUs\*

5. e-Tag Report (POUs w/ PCC 1 or 2 RPS claims from non-CBAs)
6. Hourly Report (POUs w/ PCC 1 RPS claims scheduled from non-CBA to CBA)
7. POUs with Green Pricing Program or Shared Renewable Generation Program
8. POUs with qualifying hydroelectric generation under Pub. Util. Code § 399.30 (k)
9. POUs with qualifying procurement of coal-fired generation meeting criteria of Pub. Util. Code § 399.30 (l)(1)(A)
10. POUs meeting criteria of Pub. Util. Code § 399.18

\*All requirements may not apply to all POUs

# Select FAQs for POU

## What is the verification timeline for RPS Compliance Period 4?

- Individual timeline approach.

## Can I submit a contract that is fully executed but is years out from delivering electricity products?

- Yes, fully executed contracts can be submitted prior to reporting deadlines. Early submittal can speed up verification and compliance process.

## The e-Tag status in RPS Online shows “Generation Data Needed.” Am I required to submit e-Tag data?

- Only if you have non-CBA claims.


