

# Frequently Asked Questions – CEC Solar Equipment Lists

## General Inquiries

- 1. *Is my product required to be included in the California Energy Commission's (CEC's) Solar Equipment Lists (SEL) to be sold or installed in California?***

No. The CEC does not require submittal of information to the SEL as a condition for complying with Title 20 appliance efficiency standards or for installing equipment in California. Some utilities or local governments may use the CEC's SEL during their interconnection or permit application processes.

- 2. *Who can submit requests to add equipment to the CEC's SEL?***

All requests to add equipment to the CEC's SEL must be made by the equipment manufacturer who is identified on the certificate of compliance for the associated safety standard. For multiple listing certifications, basic listee manufacturers and multiple listee manufacturers cannot submit an equipment request on behalf of one another.

- 3. *As a manufacturer, how do I check the status of my equipment request?***

You can check the [Status of Open Equipment Requests](#) by the R-ID # that was included in the confirmation email sent to the manufacturer contact provided on the equipment request form. The status of open equipment requests is updated every business day.

- 4. *How do I add equipment to third-party software (e.g., PowerClerk, SolarAPP+, Symbium) that utilizes CEC SEL data?***

Please contact the third-party software provider.

- 5. *Is a fee required to include equipment on the CEC's SEL?***

Currently there are no fees for having equipment included in a CEC solar equipment list.

- 6. *Am I allowed to use the CEC's logo in my equipment data sheet or marketing materials?***

No. The CEC's seal and logo may not be used without permission. The CEC is aware of statements in marketing materials stating or implying CEC approval of products or services. The CEC does not endorse, favor, or recommend any particular product or service. See [Use of the Energy Commission Seal and Logo](#).

- 7. *Does the CEC perform testing on the products included in the SEL?***

No, the CEC does not perform any product testing. The CEC's SEL includes equipment meeting established national safety standards and performance standards. Third-party testing is required for most equipment types in the SEL. See the instructions for each equipment type in the [accordion section of the SEL homepage](#).

## Installation, Interconnection, and Permitting Inquiries

**1. *How do I choose the right solar panels, or other equipment, for installation?***

The CEC does not provide any system design assistance. Inclusion of a specific product in the SEL does not constitute or imply an endorsement, recommendation, or approval by the CEC. See the Contractors State License Board [Solar Smart](#) webpage for consumer information.

**2. *Can you help with my building permit?***

No. The SEL program does not work directly with the installation or interconnection of equipment. Please contact your Authority Having Jurisdiction (AHJ), typically the city or county government, for help with a building permit.

**3. *Can you answer questions about my utility interconnection application or permission to operate (PTO)?***

No. The Solar Equipment Lists program does not work directly with the installation or interconnection of solar equipment. Please contact your utility.

## Vehicle-to-Grid Equipment List (V2GEL) Inquires

**1. *What is the CEC's Vehicle-to-Grid Equipment List (V2GEL)?***

The CEC's V2GEL includes bidirectional devices with vehicle-to-grid (V2G) functionalities and bidirectional devices with vehicle-to-home (V2H)/vehicle-to-business (V2B) functionalities that can operate in parallel with a utility grid. See the [V2GEL](#) webpage for more information.

The SEL and the V2GEL are separate programs. Some bidirectional equipment may be included in both lists – in the SEL for photovoltaic (PV) and stationary storage functionalities and in the V2GEL for V2G/V2H/V2B functionalities.
